Prayer for starting a specific case. Sub:

Sir,

In producing herewith the driver namely Subhas Roy (26 yrs) S/O - Miton Roy, Vill.- Banspitali, PS-Saltora, Dist-Bankura along with seized Tractor Mahindra YUVO 415 DI bearing Registration No.WB68AG6769 loaded with sand and attached with Seizure list, Memo

of Arrest in respect of the supra noted person before you.

The nub of the fact in a nutshell is that on 27.11.2022 while I SI Subrata Patra along with force left the PS for performing mobile duty in PS area. During my mobile duty, I received a tip off at 15:45 hrs that 01 (one) suspicious tractor loaded with sand was proceeding towards Hansdima through Hansdima-Poradiha road. Subsequently, I along with force proceeded towards the said road to work out the tip off. While I along with force arrived Hansdima-Poradiha road near Mohanpur village and found that 01 (one) tractor was proceeding towards Hansdima along Hansdima-Poradiha road at about 16:05 hrs. I along with force intercepted 01 Tractor Mahindra YUVO 415 DI bearing Registration No.WB68AG6769 attached with Trolley was loaded with sand. On being asked, the driver of the vehicle disclosed his name. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. So it is reasoned to belief that the accused in conspiracy with the owner of vehicle procured the said sand form Damodar River bed by fraudulently means or theft by any means for transporting the same. So I, seized the Tractor Mahindra YUVO 415 DI bearing Registration No.WB68AG6769 attached with Trolley loaded with sand (approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Subhas Roy (26 yrs) S/O - Miton Roy, Vill.- Banspitali, PS-Saltora, Dist-Bankura after informing the ground of his arrest and issued Memo of Arrest against him. Thereafter, I brought the seized tractor to Santuri PS compound.

Under the above facts and circumstances kindly take lawful action against the driver namely Subhas Roy (26 yrs) S/O - Miton Roy, Vill.- Banspitali, PS-Saltora, Dist-Bankura and the owner of the vehicle as they committed offence u/s 379/411/414/120B IPC & 21(I) (4) of

Mines and Minerals (R&D) Act-1957.
