Respected Sir,

In producing herewith 18.650 tons coal out of this 01 (one) kg coal seized as Sample with proper seizure list. The fact of the case in brief is that on 28.11.22 at about 20:25 hrs when myself along with force were on Evening mobile duty then received a source information that some persons near at Kabar Sthan of Murulia village engaged for extracting, lifting and transporting of illegal coal for clandestine business hatching a criminal conspiracy with a view to wrongful gain after forming a racket.

Accordingly I informed the matter to O/C Santuri PS and as per his direction I along with force went there to work out the information.

Accordingly I along with accompanying force reached at that spot at about 21:05 hrs. Seeing our police van from a distance some people who were engaged in extracting coal managed to escape before we could get at them. After that we searched the spot and found 18.650 tons coal out of this 01 (one) kg coal seized as Sample from that spot. Accordingly, I held local enquiry to know the involved persons to establish identity and found (1) Sk Mehetab, S/O Sk Intaz, (2) Sk Babua, S/O Sk Akbul both are of Vill-Murulia, PS-Santuri, Dist-Purulia by the available witnesses. It is reasonable to belief that above noted persons who managed to flee away from that spot were engaged for extracting, lifting and transporting of illegal coal for clandestine business hatching a criminal conspiracy with a view to wrongful gain after forming a racket. So the above noted persons are liable for committed an offence punishable U/S 379/411/414/120B IPC & r/w Sec 30(2) CMN Act.

I therefore pray that kindly start a specific case against above noted persons as per law and arrange its investigation.
