In producing herewith arrested offending driver namely Ramesh Mahato (35 Yrs), S/O- Shaktipada Mahato of Vill- Dhanara, PS- Arsha, Dist- Purulia along with one seized Red Colour Bolero bearing Registration No. JH05AA/0542.


I, Gnan Sankar Pati S/O- Ramani Ranjan Pati of Vill+P.O- Chaka, PS- Khatra, Dist- Bankura at present posted at Tamna PS, Dist- Purulia as ASI of Police beg to report that today myself along with NVF/0151 Rajib Mahato and HG/1903 Haripada Tudu all of Tamna PS were performing anti-crime day mobile duty on Purulia-Tata road side area under Tamna PS vide Tamna PS CC No- 4935/22 Dtd- 02.11.2022 & Tamna PS GDE No. 65 Dtd- 02.11.2022 at about 15:35 hrs. at Tamna More under Tamna PS, Dist- Purulia, I found one Red Colour Bolero bearing Registration No. JH05AA/0542 was coming from Balarampur side rashly and negligently. We try to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop the said vehicle at near Ashirbad Atta Factory, Damda under Tamna PS, Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person under proper memo of arrest after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC. I also seized the Red Colour Bolero bearing Registration No. JH05AA/0542 in presence of witnesses and informed him and his relatives regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Ramesh Mahato (35 Yrs), S/O- Shaktipada Mahato of Vill- Dhanara, PS- Arsha, Dist- Purulia.
