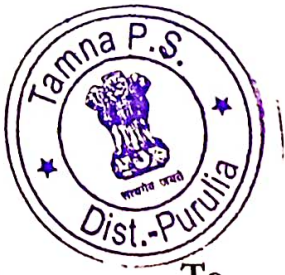

Respected Sir,

I, Surajit Kumar Das S/O- Samir Kumar Das of Vill- Kalipur Majhpara, P.O- Karidhya, PS- Suri, Dist- Birbhum at present posted at Tamna PS, Dist- Purulia as SI of Police of Tamna PS along with force return to PS and brought one seized Red colour Mahindra B 275 DI Tractor, bearing Registration No. JH09AM/5550, having Engine No. RJA2EAN2139 & Chassis No. MBNABAEAKJRA02135 attached with trolley without any number plate loaded sand (approx. 100 cft.) and lodged this complaint to the effect that today i.e on 26.11.2022, myself along with force i) NVF 1095 Tanuram Mahato and ii) HG/1747 Ajit Hembram were performing PS area mobile duty vide Tamna PS C.C No. 5229/22 Dtd- 26.11.2022 & Tamna PS GDE No. 1108 dated- 26.11.2022. During my mobile duty at about 14:05 hrs. received credible source information that one Red colour Tractor is carrying sand illegally along Dandudih-Kantadih village road and coming towards Dandudih morh under PS- Tamna, Dist- Purulia. Accordingly, myself along with force left to work out the said source information. At about 14:25 hrs while we reached near Dandudih Morh under Tamna PS, Dist- Purulia found that the above noted tractor was tagged with a trolley loaded with sand (approx. 100 cft.). But seeing the Police party, driver of the tractor fled away leaving the said tractor at Dandudih More under Tamna PS, Dist- Purulia. We tried to apprehend him but failed. So, there is every reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the sand of above detained tractor. So, I seized the said Red colour Mahindra B 275 DI Tractor, bearing Registration No. JH09AM/5550, having Engine No. RJA2EAN2139 & Chassis No. MBNABAEAKJRA02135 attached with trolley without any number plate loaded sand (approx. 100 cft.). Brought the said Tractor attached with trolley loaded with sand (approx 100 cft.) at PS after arranging driver from our source.

On return to Tamna PS, kept the aforesaid seized tractor attached with trolley loaded with sand (approx. 100 cft) at PS compound and I do hereby submit a type complaint before you to start a cog case against the owner and driver of the tractor bearing Registration No- JH09AM/5550, having Engine No. RJA2EAN2139 & Chassis No. MBNABAEAKJRA02135 under proper section of law.
