In producing herewith the arrested accused persons namely (1) Ramesh Das (48 Yrs) S/O Lt. Sudhir Das (2) Raj Sharma (36 Yrs) S/O Nageswar Sharma both of Loco Colony (Jhupri) (3) Biswanath Bauri (24 Yrs) S/O Lt. Nitai Bauri of Traffic Colony (Jhupri) (4) Anup Kumar Mandal (48 Yrs) S/O Lt. Kalipada Mandal of T/144, Unit/D all of PS-Adra, Dist-Purulia before you, along with seized articles like board money amounting to RS- 255/-, 52 nos of playing eards, one burned candle, one plastic sheet from their possession as per seizure list

I beg to report that on 01.12.2022 at 00:01 hrs, I received secret information that one gambling with huge amount was going on in the abandoned Rly. Quarter at traffic Colony during my night mobile duty at North side near SERSA Ground. Accordingly I inform to I/C Adra PS and as per his direction I along with (1) C/140 Subrata Banerjee (2) C/3152 S.K. in Govt. vehicles left for Traffic Colony to work out the information, at about 00:10 hrs we reached at Traffic Colony slowly and cautiously approached towards abandoned Rly, quarter where the gambling was reportedly going on. From the inside of the abandoned of the Rly, quarter we over heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and then some persons fled away but we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels (Police Uniform with nameplates) and Mobile Phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (One plastic sheet on the floor) and playing eards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash for wrongful loss to one and wrongful gain to another. After that in presence of police party the board money of Rs 255/-(Two hundred fifty five only) with different denomination, 52nos of Playing cards and one plastic sheet, one burn candle were seized for the gaming board in between 12:30 hrs to 12:45 hrs under proper seizure list duly signed by police witnesses as the place is lonely so I found no public witness.

As such for committing offence punishable u/s- 3 & 4 of W.B.G & P.C Act all the above noted 04 (Four) persons were arrested, issuing arrest memo at 12.15 hrs to 12.30 hrs. After arrest 1 offered them medical treatment but they denied.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons & others and arrange for its investigation.
