No-WB56G/0249 loaded with 02 sacks Coal dust weight approx 100kgs, each sack 2) Dhananjay @ Dhanu Gorai (34Yrs) S O Hiralal Gorai (Rider of one Black and Red colour TVS XL-100 bearing Reg. No-WB38AM 0564 loaded with 02 sacks Coal dust weight approx 100kgs, each sack both of Vill- Biltora, PS-Raghunathpur, Dist- Purulia along with seized articles and all connected papers.

1, beg to submit that, 1 SI Dipak Kumar Pandey along with C/1290 Kuntal Nandi, C/506 Bhutnath Singh Sardar all of Adra PS vide Adra PS CC No-4022/22 dtd.02.12.2022 while performing day mobile duty at 12:05 hrs received a credible source information that some persons are transporting coal dust by their Motorcycle towards Gosaidanga village, towards Chinpina-Gosaidanga morum road which has been procured by means of theft or any fraudulent manner. After receiving the said information we have started to move towards Gosaidanga village on that road under our P.S. jurisdiction with a view to intercept the said motorcycles. At about 12:45 hrs we found some motorcycle, loaded with coal dust in plastic sack are coming from Chinpina side. Seeing the police party all the riders of the said 02 Motorcycle left their Motorcycle on road and started to fled away. However after a small chase we could able to apprehend all the above noted 02 persons. On being demand all the apprehend persons failed to produce any valid document in respect of the procured coal dust as well as their motorcycle. On verification it is reasonable to believe that the rider's of the above noted motorcycle collected coal dust either theft or any illegal means and transporting to run clandestine business for wrongful gain and they are engaged, in winning or mining coal from the whole or part of any land in respect of which no valid prospecting license or mining lease or sublease is in force. So, I seized said 02 Motorcycle along with total 04 sacks of coal dust total weight approx 400kgs under proper seizure list duly signed by the witnesses and accused persons and arrested all the above noted accused persons maintain all formalities of court apex. There was no such public witness came forwarded after requesting at that time to stand as witness of seizure, so I seized all the items as mentioned in seizure list in presence and signed by police party. The whole process was done in between 12.50 hrs to 13.50 hrs. Thereafter I brought the seized 02 motorcycle along with 04 sacks of coal dust total weight approx 400 Kgs. at Adra PS compound.

I, therefore pray before you to lodge a specific case against (1) Haru Gorai (44) S/O-Shymapada Gorai (2) Dhananjay @ Dhanu (34Yrs) S/O Hiralal Gorai both of Vill- Biltora, PS-Raghunathpur, Dist-Purulia under proper law.
