Sir,

In producing here with the arrested accused persons namely (1) Rupesh Barma (47 Yrs) (2) Mukesh Barma (45 Yrs) both S/O Lt. Om Prakash Barma both of Vill - Panchudanga, P.S. - Adra, Dist - Purulia, A/P - Vill-Chhaigada near Mahila Samity, PS- Adra, Dist - Purulia, (3) Bhandari Harijan (25 Yrs) S/O Pyarelal Harijan of Vill-Sebanagar, PS- Adra, Dist-Purulia (4) Mukesh Prasad (42 Yrs) S/O Lt. Shibsankar Prasad of Kurmidih Bazar, PS-Balidih, Dist-Bokaro(JKD) A/P -C/O Rupesh Barma of Vill-Chhaigada near Mahila Samity as disclosed by the arrested accused persons along with seized articles under proper seizure list (enclosed here with) i.e. (i) Exhibit Mark-'A'- one white plastic carry bag containing 3 Kg 34 gm. Ganja packed & labeled (ii) Exhibit Mark-'A1'- 100 gm of Ganja taken from Exhibit-A as test sample marked and labeled (iii) Exhibit Mark-'A2'- 100 gm of Ganja taken from Exhibit-A as security sample marked and labeled. All Exhibits are in properly sealed and labeled condition under proper seizure list.

1. SI Dipak Kumar Pandey of Adra PS do here by lodge this complaint as suo-moto to the effect that today (15/12/2022) at 21:05 hrs received a secret information from my source that the above noted persons was stocked Ganja illegally and selling the same to hike price for his personal gain at Chhaigada near Mahila Samity. On received such information I immediately diarized the fact in GD vide Adra PS GDE No 650 dated- 15.12.2022 and informed the matter to IC Adra PS who pleased to direct me to proceed to work out the information. As per procedure a email message has been sent to SDO, Raghunathpur through E-Mail to depute one executive magistrate to accompany in the search and seizure process through Adra PS G-mail. As per direction of IC Adra PS I SI Dipak Kumar Pandey accompanying with evening mobile duty officer & force (i) ASI Laxmoy Chatterjee (ii) CP 4250 Kuntal Nandi (iii) HG/1944 Rajesh Das, all are Adra P.S. left at 21:05 hrs for Chhaigada near Mahila Samity, after arranging inventory list, by Govt Vehicle bearing Reg. No WB 56C/8995 attached to Adra PS equipped with govt supplied arms and ammunition, weighing machine, investigation kit box, white paper, gala, white cloth, carbon paper, stamp pad, seal of Adra PS, brown envelope etc. vide Adra PS CC No. 4254/22 Dt. 15.12.2022 & Adra PS GDE No-640 dt 15.12.2022

At about 21:45 hrs arrived at Chhaigada near Mahila Samity and entered in a Jhupri of Rupesh Barma (47 Yrs) S/O Lt. Om Prakash Barma of Vill-Chhaigada near Mahila Samity of under Adra PS and cordons the PO. In that mean time IC Adra PS reached the said spot and as per his direction on asked they disclosed their identity as (1) Rupesh Barma (47 Yrs) (2) Mukesh Barma (45 Yrs) both S/O Lt. Om Prakash Barma both of Vill - Panchudanga, P.S. - Adra, Dist - Purulia, A/P - Vill-Chhaigada near Mahila Samity, PS- Adra, Dist - Purulia, (3) Bhandari Harijan (25 Yrs) S/O Pyarelal Harijan of Vill-Sebanagar, PS-Adra, Dist-Purulia (4) Mukesh Prasad (42 Yrs) S/O Lt. Shibsankar Prasad of Kurmidih Bazar, PS-Balidih, Dist-Bokaro(JKD) A/P -C/O Rupesh Barma of Vill-Chhaigada near Mahila Samity We informed them that we have specific information that they has illegal narcotic substance and they admitted that they were selling illegally Ganja which is use as contraband narcotic substance without any valid papers and others they were selling to another public.

In the meantime one Shankar Bauri (22 Yrs) S/O Lt. Gobinda Bauri of Vill-Chhaigada, and 2) Sai Kumar S/O Srinivas Rao of Vill- Chhaigada, both of PS - Adra, Dist- Purulia who were returning to their home via above noted PO. IC Adra PS requested them to wait for some while as disinterested witnesses, as because we will be ready to search and above noted all processes in presence of them

I also issued notice as per NDPS Act and a per order of IC Adra PS to above noted all need. Persons in order to conduct them search by a Executive Magistrate or by any gazetted Police Officer They informed in writing that they have no objection if the search conducted either by any Gazette Police Officer or by any Executive Magistrate.

Insp. Partha Pratim Roy, IC Adra PS informed me that a Executive Magistrate could be made available as such odd hours of the night. Insp. Partha Pratim Roy, IC Adra PS disclosed his identity before above noted all accused persons and asked me to issue notice to them, offering them to search the available police personnel present there as well as the public witness present there, but they showed no interest and refused to conduct any search of the police personal and public witness in writing.

As per direction of IC Adra PS, I conducted search, Seize & label and arrest of 1) Rupesh Barma (47 Yrs) (2) Mukesh Barma (45 Yrs) both S/O Lt. Om Prakash Barma both of Vill - Panchudanga, P.S. - Adra, Dist - Purulia, A/P - Vill-Chhaigada near Mahila Samity, PS- Adra, Dist - Purulia, (3) Bhandari Harijan (25 Yrs) S/O Pyarelal Harijan of Vill-Sebanagar, PS-Adra, Dist-Purulia (4) Mukesh Prasad (42 Yrs) S/O Lt. Shibsankar Prasad of Kurmidih Bazar, PS-Balidih, Dist-Bokaro(JKD) A/P -C/O Rupesh Barma of Vill-Chhaigada near Mahila Samity in between 21:45 hrs to 22:55 hrs.

During search in said Jhupri I found and recovered one white plastic carry bag containing 3 Kg 34 gm. Ganja. On interrogation they confessed that it is the Ganja and he is habituated in dealing of such clandestine illegal business of Ganja for selling purpose for their wrongful gain, knowing the same is a punishable offence. On demand they failed to produce any documents or justify regarding the storage of Ganja. According to the direction of IC Adra P.S I weight the Ganja and it resulted total in 3kg 34 grams in weighting machine. On reasonable belief, an offence has been committed in respect of recovered substance believe to be Ganja from which 100 Gram were taken in 02 (Two) brown envelope as test samples and security samples from mother sample. The said articles were seized U/S 43 of NDPS Act 1985 under proper seizure list duly signed by the witnesses as well as above accused persons. I also supplied a copy of seizure list to all accused person. I arrested above all accused persons after maintaining all formalities. The seized articles were properly labeled and sealed. Also offered them for their medical checkup but they refused the same. Informed them the reason of arrest.

I prepared another inventory list containing weighting machine, investigation tool kit, some white paper, used gala, rest white cloth, used carbon paper, stamp pad, seat, burnt candle, mother samples consists of 02kg 834 gram Ganja like substance in white plastic and two brown envelop contains 100 gm (each) Ganja like substance in presence of witnesses and accused persons. The entire process was supervised and directed by IC Adra PS, Sri Partha Pratim Roy.

At PS above accused persons were searched by Police personnel and put him into the PS lock up after observing all Hazat rules and informed on duty table Officer and cautioned the sentry duty about above accused persons.

That, I the complainant drafted and prepared the complaint by typing on going through the records of the Case. The relative of the arrested accused persons are being informed.

The accused persons are liable for prosecution U/S- 21(b) of NDPS Act, 1985 as amended up to date.

Under the above fact and circumstances I like to lodge an FIR against 1) Rupesh Barma (47 Yrs) (2) Mukesh Barma (45 Yrs) both S/O Lt. Om Prakash Barma both of Vill - Panchudanga, P.S. - Adra, Dist - Purulia, A/P - Vill-Chhaigada near Mahila Samity, PS- Adra, Dist - Purulia, (3) Bhandari Harijan (25 Yrs) S/O Pyarelal Harijan of Vill-Sebanagar, PS-Adra, Dist-Purulia (4) Mukesh Prasad (42 Yrs) S/O Lt. Shibsankar Prasad of Kurmidih Bazar, PS-Balidih, Dist-Bokaro(JKD) A/P -C/O Rupesh Barma of Vill-Chhaigada near Mahila Samity U/S- 21 (b) of NDPS Act 1985 as amended up to date and arrange for its investigation.
