Sir,

In producing here with one arrested accused namely Kashinath Paswan (54 Yrs) S/O Lt. Sukdeh Paswan of Traffic Colony (Jhupri), PS Adra, Dist-Purulia along with following seized articles with seizure list and Seizure Report.

1) 12 [Twelve] bottles DIC KAROMA 400 ml each containing 46.10% Vol each bottle.

I S/o Madan Chandra Supakar of Adra PS do have by lodged a complaint against accused namely Kashinath Paswan (54 Yrs) S/O Lt. Sukdeh Paswan of Traffic Colony (Jhupri), PS Adra, Dist-Purulia to the effect that today 30/12/2022 in course of special mobile duty as per order vide Adra P.S. No. 1307/22 and 30.12.22 I received information from a reliable source that there is one accused person namely Paswan selling country spirit illegally in Traffic Colony area. From such information I informed to I/C Adra P.S. over telephone and as per his directions I along with accompanied force reached at Traffic Colony at about 18:45 hrs and held raid in a Jhupri and found that the above noted accd. person selling country spirit at his jhupri at Traffic Colony and after seeing the Police party, all the person fled away and said Kashinath Paswan has tried to conceal himself but we able to apprehend him. When he produced valid license or valid papers in respect of selling of country spirit but he failed to produce any valid license or documents in respect possessing selling the same. So it is sufficient reason to believe that above said Kashinath Paswan engaged to sale the country spirit by illegal way. So I seized the above mentioned country spirit under proper seizure list duly sign by accused person and available witnesses. I also collect sample from seized country spirit duly sealed and labeled by me. There also I arrest the above mentioned accused person with informing him the ground of arrest. The complete process was done in between 18:45 hrs to 19:45 hrs.

I therefore pray that a specific case may kindly be start against arrested accused Kashinath Paswan (54 Yrs) S/O Lt. Sukdeh Paswan of Traffic Colony (Jhupri), PS Adra, Dist-Purulia under proper section of law.
