Sir,

In producing here with one arrested accused person namely Durga Charan Hansda (59yrs) S/O Lt. Kolebar Hansda of vill- Baruadih, P.S.-Arsha Dist-Purulia along with following seized articles.

- 1) one white colour plastic container with approx 18 ltrs. of ID liquor.  
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, ASI Janardan Kumar of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 01/12/2022 at about 16.25 hrs. during my Spl. raid duty at P.S area, receive source information over telephone that the above noted accused has been selling ID liquor at Baruadih Village. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/- 1516 Arnab Sinha and C/- 1140 Dayamay Mahato both of Arsha PS rushed to the house to work out the information vide Arsha PS C.C. No. 2991/22 dtd. 01/22/2022 and GDE No. 40 Dtd. 01/12/2022 Reaching at Baruadih village at about 16.55 hrs we fixed-up in the house of above noted accd. person and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the one Durga Charan Hansda (59yrs) S/O Lt. Kolebar Hansda of vill- Baruadih, P.S.-Arsha Dist-Purulia. On demand of showing papers he failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which Approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt so, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person namely Durga Charan Hansda (59yrs) S/O Lt. Kolebar Hansda of vill- Baruadih, P.S.-Arsha Dist-Purulia under proper section of law.
