
Sub: To lodge FIR against owner and driver of one Mahindra 275 DI tractor having No. WB55B/4042 along with trolley (sand approx 60 CFT).

Sir,

In producing herewith, 01(one) New Mahindra 275 DI tractor having No. WB55B/4042 along with trolley (loaded with sand approx 60 CFT). Today on 29.12.2022 at about 08.55 hrs. acting on source information, I ASI Tapan Kr. Mahata of Arsha PS along with (i) C/-15 Sushanta Dey of Arsha P.S and (ii) C/307 Shankar Gorain of Arsha PS, Dist-Purulia, left for PS area vide C.C No. 3262 Dtd. 29.12.2022. After we reached at Gouradag Ghat, under Arsha PS at 09.55 hrs, we conducted raid on the Bank of Gouradag Ghat on the Bank of River Kansai under Arsha PS and found that 01 (one) tractor along with trolley attached with by a hinge was present at Gouradag Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at ^{Truck} ~~Bandu~~ ^{Arsha} ~~River~~, fled away. Police rushed to the tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
