On 06.12.2022 at about 11:00 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Sajal Kumar Mahanty, Sr. OE, WBSEDCL 2. Sri Prabir Adhikary, OSH, WBSEDCL, entered the premises of Sri Rajkishore Kumar, S/O- Angu Kumar of village Biddri, P.O- Tunturi, PS- Bagmundi, Dist- Purulia and found Sri Rajkishore Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA.

As Sri Rajkishore Kumar, S/O- Angu Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanty, Sr. OE, WBSEDCL 2. Sri Prabir Adhikary, OSH, WBSEDCL. The inspection team left the premises at 11:10 a.m..
