Chhutu Kumar of village Sirkadih, P.O- Kushaldih, PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 22/12/2022 at about 10:20 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sri Anup Mondal, JE (Gr-I), Bagmundi CCC, WBSEDCL 2. Sri Subhasis Mahato, OE, Bagmundi CCC, WBSEDCL, entered the premises of Sri Deepak Kumar, S/O- Lt. Chhutu Kumar of village Sirkadih, P.O- Kushaldih, Dist- Purulia and found Sri Deepak Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Deepak Kumar S/O- Lt. Chhutu Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Anup Mondal, JE (Gr-I), Bagmundi CCC, WBSEDCL 2. Sri Subhasis Mahato, OE, Bagmundi CCC, WBSEDCL. The inspection team left the premises at 10:30 a.m.
