On 22/12/2022 at about 10:40 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sri Anup Mondal, JE (Gr-I), Bagmundi CCC, WBSEDCL 2. Sri Subhasis Mahato, OE, Bagmundi CCC, WBSEDCL, entered the premises of Sri Bhisma Kumar, S/O- Late Madhu Kumar of village Sirkadih, P.O- Kushaldih, Dist- Purulia and found Sri Bhisma Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Bhisma Kumar S/O- Late Madhu Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1.
