Sir,

In producing herewith the one accused person namely Laltu Mahato (28 yrs) S/O Nitai Chandra Mahato Vill- Gosaitikra, Saridih, PS- Baghmundi, Dist- Purulia along with seized articles (1) 08 (Eight) liter ID Liquor containing in a white plastic jarcan (2) 10 (Ten) Pcs Plastic disposal Glasses, (3) 500 ml I.D liquor from SI No. 1 as sample which were seized under proper seizure list duly signed by the witnesses.

I beg to submit that today on 22.12.2022 during my special mobile duty as per Suisa OP C.C No-1452/2022 & Suisa OP GDE No-644, Dtd: 22.12.2022 received a source information. Accordingly, I SI Saurav Kanti Das along with force 1. C/2922 Alope Majhi, 2. JC/Rahul Islam Ansary 3. NVF/908 Lakhindar Singh Mura all of Suisa OP under Baghmundi P.S, Dist-Purulia reached at Villgaje Saridih tola Gosaitikra under Baghmundi PS at about 17:05 hrs and found that the above noted person is selling I.D liquor in a temporary hut beside Saridih – Gosaitikra road. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. In between 17:15 hrs to 17:25 hrs I seized (1) 08 (Eight) liter ID Liquor containing in a white plastic jarcan (2) 10 (Ten) Pcs Plastic disposal Glasses, (3) 500 ml I.D liquor from SI No. 1 as sample from his possession U/S- 67 B.E Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witnesses and accused person. Hence I arrested the above noted person at 17:35 hrs after maintaining all formalities and guidelines regarding arrest. I offered him for medical treatment but he refused.

The above noted arrested accused person namely Laltu Mahato (28 yrs) S/O Nitai Chandra Mahato Vill- Gosaitikra, Saridih, PS- Baghmundi, Dist-Purulia committed an offence U/S- 46 (A)(c) B.E Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific case may kindly be started against the said accused person under proper section of law and arrange its investigation.
