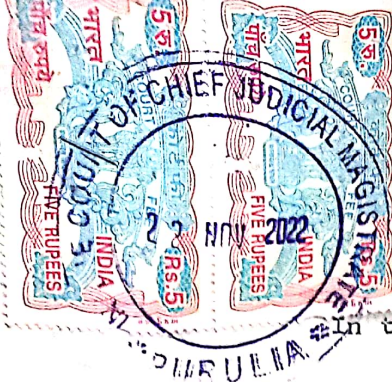

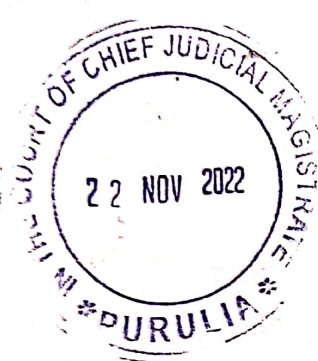

1.---That the complainant is the legally married wife of the accused No.1 Mithun Bauri. Their marriage were solemnized on 20th day of May 2022 after performing all religion rites and ceremonies prevailing in their community and according to Hindu rites.

2.---That at the time of marriage between the complainant and accused No.1, the father of the complainant gave Rs.1,00,000/- (Rupees one lakh) in cash, 3 Bhares Golden and 7 Bhares Silver ornaments, Wrist Watch, Cycle, Thala, Bati, Glass and other valuable articles valued Rs.30,000/- (Thirty thousand) to the accused persons as per their demand as dowry.

3.---That after marriage complainant had been to the house of the accused persons at village Nekre and started her matrimonial home with lots of dreams and aspiration and the marriage was duly consummated. .
Accused No.1 is husband, accused No. 2 and 6 are father and mother-in-law, Accused No.3 is Brother-in-law, accused No.4 is nanad, accused No.5 brother-in-law, 's wife of the complainant.

4.---That after marriage the complainant and accused No.1 resided as husband and wife peacefully only for three months but there after accused No.1 to 6 began to make torture both physical and mentally to the complainant.

5.---That during the stay of the complainant, the accused persons No.1 to 6 told the complainant to

to bring Rs. 20,000/- (Rupees Twenty thousand) from her father. The father of the complainant gave Rs. 10,000/- (Rupees Ten thousand) to the accused persons as per demand, Again the accused persons demanded Rs. 10,000/- and told the complainant to bring the same from her father. But the complainant and her father expressed their inability to meet the illegal demand of the accused No. 1 to 6.

6.---That on 18-07-2022, the accused persons No. 1 to 6 forcibly caught hold the complainant and sprayed Kerosine in the Sari and all over the body of the complainant and attempt to set fire in the body but grace of God, mother and Brother of the complainant entered in the house of the accused persons and they rescue from the hands of the accused and also grace of Got any how complainant saved her life. The complainant as she is a good wife tolerated all the illtreatment, some how and for that several time. The complainant went to her father's house and reported the matter. The father of the complainant came to the house of accused persons and told the accused persons 1 to 6 keep the complainant peacefully. But they did not hear his good counselling but they became very angry and rebuked him in filthy language and the accused No. 1 to 6 told loudly to the father of the complainant that you have give another Rs. 20,000/- (Rupees twenty thousand) as dowry to them, otherwise they will kill her.

7.---That the accused No. 1 to 6 on many occasions tried to finish the life of the complainant by strangulation but the grace of life. On

but the grace of God, the complainant save her life. One day accused No.1 used to come in his house in drunken condition and assaulted the complainant in presence of witnesses No.1 and 2.

8.---That on 27-07-2022 the accused persons No.1 to 6 assaulted the complainant ~~by~~ by lathi in her back mercilessly and snatching the ornaments from the complt. and drove the complainant from her matrimonial house and since then complainant has been staying her father's house with utmost difficulties.

9.---That the accused persons No.1 to 6 still threatening to kill the complainant and her father, Mother, brother by different ways that due to constant threatening torture, illtreatment harassment of the accused persons No.1 to 6 the complainant and her father, mother, the complainant became sicking nervous and failed on insecure.

10.---That the incident was reported to the local police of Balarampur P. S. and also to the S.P.Purulia. But the police of Balarampur P. S. are quite mum and has not started any police case against the accused persons. So the complainant is bound to file the instant petition for pro or relief.

In the circumstances, it is therefore prayed that your Honour will kind enough to sent this complaint petition to Balarampur P. S. and directed them to investigate the case treating this as F.I.R. U/s 156(3) Cr.P.C.
