Sir,

I, SI Amaresh Das, DEB, Purulia, do here by lodge complaint being produced the accd person namely Sanjit Pal (51 Yrs), S/O- Lt. Bijay Pal of Vill- Balarampur (Gosala Road), PS- Balarampur, Dist Purulia along with the following seized articles

- 1) 09 (Nine) Pcs. Filling LPG cylinders (domestic) of INDANE company
- 2) 05 (Five) Pcs. Empty LPG cylinders (domestic) of INDANE company
- 3) 02 (Two) Pcs 5Kg loaded LPG domestic cylinder of INDANE company
- 4) 02 (Two) Pcs empty LPG domestic cylinder of INDANE company
- 5) 01 (one) Pcs 2 Kg empty Locale made cylinder.
- 6) 01 (one) Pcs 4 Kg empty Locale made cylinder.
- 7) 04 (Four) Pcs Nozzle apparatus, having length- 2.5 Inch each (Approx)
- 8) One electric weight machine "The perfect weighing solution"

to the effect that today on 08.12.2022 on the basis of secret and credible information I, along with W/C 88 Pradyut Mandal, HG/1427 Benimadhab Char had been to Balarampur PS and submitted one requisition to OC Balarampur PS for rendering assistance and the credible information at Balarampur PS at 10:05 hrs. has been noted vide Balarampur PS GDE No- 852, dtd- 08.12.2022 at 10:10 hrs. Thereafter we along with ASI Dulal Sing Sardar and force of Balarampur PS left for Balarampur (Gosala Road) under Balarampur PS to work out the information. On arrival at Balarampur (Gosala Road) at about 11:55 hrs to work out the information, I asked two local people viz. (1) Bablu Mansuri (49 yrs), S/O- Lt. Nazimuddin Mansuri of Vill- Balarampur, PS- Balarampur, Dist Purulia to assist us for holding raid, search and seizure in the house of one Sanjit Pal (51 Yrs), S/O- Lt. Bijay Pal of Vill- Balarampur (Gosala Road), PS-Balarampur, Dist Purulia. Prior to holding raid in the repairing shop cum house, we noticed huge nos. of domestic LPG cylinder kept inside the house along with apparatus which is used for refilling LPG from one to another cylinder. The owner namely Sanjit Pal was asked to produce valid documents / license for running his business in respect of possessing such domestic LPG cylinders and also such business of refilling, but the owner failed to produce any valid documents / license for running such illegal business. Thereafter myself along with accompanied officers and force along with the active assistance of above noted one local witnesses as above held raid in the repairing shop cum house of Sanjit Pal (51 Yrs), S/O- Lt. Bijay Pal of Vill- Balarampur (Gosala Road), PS-Balarampur, Dist Purulia, after observing all formalities relating to search and seizure in between 12:05 hrs to 13:05 hrs.

As such I seized the articles with proper labeling in presence of local witnesses and police witnesses under proper seizure list from the repairing shop cum house of Sanjit Pal in between 12:05 hrs to 13:05 hrs.

Sanjit Pal (51 Yrs), S/O- Lt. Bijay Pal of Vill- Balarampur (Gosala Road), PS-Balarampur, Dist Purulia failed to produce any valid documents / papers for running such business hence he violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985. Hence he has committed an offence punishable u/s 7(1)(a)(ii) of E.C.Act'1955. It appeared that if he is not arrested now he may tamper with evidences and he is also very likely to hinder investigation. So the said Sanjit Pal (51 Yrs), S/O- Lt. Bijay Pal of Vill- Balarampur (Gosala Road), PS-Balarampur, Dist Purulia was arrested after informing him the ground of arrest, issued Memo of Arrest to him in presence of his brother duly signed by him at 13:15 hrs.

In course of local enquiry it revealed that said Sanjit Pal is running clandestine business of LPG Gas Cylinder and also selling LPG after refilling in other cylinder since long without having any authority or license and only for causing his wrongful gain and causing loss of revenue to the Govt.

I therefore request you to start a case u/s 7(1)(a)(ii) of E.C.Act'1955 against accused Sanjit Pal (51 Yrs), S/O- Lt. Bijay Pal of Vill- Balarampur (Gosala Road), PS-Balarampur, Dist Purulia.

As per order of SP (DEB), Purulia ASI Swapan Chakraborty of DEB, Purulia will investigate the case.
