



I would like to state here that on 29.12.2022 at 10:05 hrs received information that one Kalpana Mahato (ICDS worker) who was restrained / detained in ICDS centre at Maldih village in a house by lock and key by approx 250 (two hundred fifty) males and females of Maldih villagers regarding the PMAY scheme and tried to assault her. This refers Balarampur P.S GDE No- 1346 date- 29.12.2022. After that I along with force, LC, LCV left P.S to work out the information as per kind order of O/C Balarampur P.S by Govt. vehicle vide its Reg. No- WB56D/9059 and vehicle No- JH05BA/2313. After arriving at Maldih village (at about 10:35 hrs morning) near the house of Madhusudhan Mahato, found unruly mob with huge gathering including female members were present there and restrained one Kalpana Mahato W/O- Brihaspati Mahato (ICDS worker) of Maldih village inside a house by lock and key as well as detained another 02 (two) female persons namely Kalpana Mahato W/O- Lt. Nabakishor Mahato, (Asha Karmi) , Anupama Mahato W/O- Sripati Nath Mahato (AWH of ICDS) all of Maldih village were restrained surrounded by agitated huge unruly mob. We the Police party tried our label best to manage the situation also requested them to maintained peace of the area but they did not pay any heed of our words. After that G.P member namely Bholanath Mahato of same village also came to the spot and requested them not to break the peace of the area as well as tried to solve out but in vain. In the main time the representative of BDO office staff namely Bimal Paramanik Executive Assistance reach there but the mob became more furious regarding the why they did not get the house in PMAY scheme. We the Police party again requested to the agitated mob to maintain peace but they did not pay any heed. After long consultation and persuasion with the mob from 10:35 hrs to 14:30 hrs but they did not dispersed and all the mob goes wrong and became more furious being excited and instigated also started shouting মার শালা পুলিশকে, যবে ঢুকিয়ে আগুন জ্বালিয়ে দে । The detained persons feeling illness and

reaching the re-enforcement officer and force at about 14:30 hrs. We all approach to recover the said detained persons and we loudly commanded the said unlawful assembly to dispersed with maintain all procedure. Then mob seriously and violently suddenly attacked us with Lathi, deadly weapon and pelting bricks and stone heavily as a result, I suffered injury on my right hand, right chest and right foot as well as SI Bhudev Ch. Kuiry, ASI Sujit Mondal, C/2994 Abhijit Lohar, C/1465 Gorachad Pal, LCV/835 Sukurmoni Soren, LCV/834 Parbati Soren, C/2391 Kamal Mahato, LCV/ Rabani Baskey all of Balarampur P.S were received serious injury. Finding no alternative way, in order to prevent further mischief and to save the life of Police personnel as well as safe the life of recovered persons and under the command of superior we resorted to push to dispersed. Thereafter all the unruly mob dispersed from the spot and we able to apprehended above noted 10 (ten) persons from the spot with Lathi after interrogation they confessed their guilty and arrested them under proper formalities and modesty of women in presence of female Police persons also seized the above mentioned articles under proper seizure list on being asked they confessed they following persons are involved with conspiracy and assaulted to the Police party. After that I along with force, arrested accused persons, seized articles left the spot to Bansgarh CHC for medical treatment also referred some patient for better treatment.
