## Respected Sir,

In producing here with arrested accused persons namely 1. Sandip Rajak (28 Yrs ) S/O- Lt. Mutuk Rajak of vill-Madhupur 2. Laxman Tantubai (29 yrs) S/O- Madhab Tantubai of Vill-Mirgichami, both of P.S- Bandwan, Dist-Purulia along with seized illicit Distilled liquor & other seized articles I beg to submit that today i.e. on 15.12.22 at about 15:45 hrs I received a credible source information while I was engaged in spl. Mobile duty that two persons as mentioned above is preparing & selling Illicit Distilled liquor without any valid license under the Arjun tree at Duarsini more, P.S- Bandwan, Dist- Purulia. Accordingly, I along with force (C/3112 Avijit Bera and C/2923 Bamapada Lohar both of Bandwan PS) vide Bandwan PS C.C No. 5152 /22 date. 15.12.22 left for Duarsini more P.S- Bandwan, Dist- Purulia to work out the said source information held raid at that particular place as identified by the source and found that the said persons was preparing illicit Distilled liquor and pouring and mixing some substance like white powder and white coagulated substance. On asking they disclosed their identity as noted above and accordingly recognized the white powder like substance as 'Nishadol'(approx 200 gms contained in a plastic) and the white coagulated substance as Bakhar, an intoxicated substance having which is likely to cause disability or death to human being. They stated that he usually prepares illicit distilled liquor in bulk quantity for the purpose of selling. But on demand they failed to produce any valid documents / licence in respect of preparing and selling of illicit distilled liquor. Accordingly I seized all the illicit distilled liquor and other articles; 1. 20 liters approx Illicit distilled liquor in a jarricane, 2. One clay handi, 3. One aluminium handi 4. One aluminium pipe measuring 3 ft approx 5. One plastic packet containing Bakhar like substance weighing 500 gm 6. One plastic packet containing Nishadal weighing 200 gm which are used to prepare illicit distilled liquor after preparing proper seizure list duly signed by witnesses and the seizure was done in between 16:15 hrs to 16:35 hrs. One litre illicit distilled liquor has been kept and labelled as sample bottle. Then I arrested them after preparing proper arrest memo and maintain all other legal formalities as laid down by Hon'ble Supreme Court at 16:45 hrs as they are committed offence u/s 46 AA B.E Act, 1909 and took them to PS and put in lock up maintain all hazat rules.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started u/s 46 AA B.E Act 1909 against the arrested accused persons namely 1. Sandip Rajak (28 Yrs ) S/O- Lt. Mutuk Rajak of vill-Madhupur 2. Laxman Tantubai (29 yrs) S/O- Madhab Tantubai of Vill-Mirgichami, both of P.S- Bandwan , Dist-Purulia and arrange for its investigation.
