

Sub: Complaint against (i) Babulal Hansda (20 Yrs) S/o- Labin Hansda (ii) Sunil Hansda (20 Yrs) S/o- Rabi Hansda both of Vill- Ratandih, PS- Balarampur, Dist-Purulia to start a specific case under proper section of Law.

Sir,

In producing herewith arrested accused persons namely (i) Babulal Hansda (20 Yrs) S/o- Labin Hansda (ii) Sunil Hansda (20 Yrs) S/o- Rabi Hansda both of Vill-Ratandih, PS- Balarampur, Dist- Purulia and seized (i) One blue colour Hero Glamour bike having registration No- JH 05AF 4128 (ii) Approx 20 Liters I.D liquors (Cholai) kept in two Jerakin approx 10 liters each (ii) ½ Liters taken from each Jerakin as sample as per enclosed seizure lists.

I, PSI Aloke Rana of Barabazar PS do here by lodge this complaint against (i) Babulal Hansda (20 Yrs) S/o- Labin Hansda (ii) Sunil Hansda (20 Yrs) S/o- Rabi Hansda both of Vill- Ratandih, PS- Balarampur, Dist- Purulia. I beg to state that today i.e. 20.12.2022 at about 17.25 hrs myself along with C/- 975 Ashoke Saharay & C/-1211 Chunaram Hembram left for special I.D liquors raid duty at PS area. At about 17.45 hrs I received information that one bike was coming from Balarampur side by carrying I.D liquor and going towards Patpur village side for selling. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction we detain one motorcycle carrying I.D liquors and two persons; one riding this bike and seating this bike by holding two plastic Jerakin. Seeing the Police party the alleged persons tried to flee away, but we apprehended them with the help of the Police party and on being searched I found that they were carrying approx 20 Liters I.D liquors (Cholai) kept in two Jerakin approx 10 liters each. On demand, they failed to produce any valid documents / License in respect of carrying I.D liquors (Cholai). On being asked they confessed their guilt and stated that they carried the ID liquors with intent to sell to make their own profit. They disclosed their identity as (i) Babulal Hansda (20 Yrs) S/o- Labin Hansda (ii) Sunil Hansda (20 Yrs) S/o- Rabi Hansda both of Vill- Ratandih, PS- Balarampur, Dist- Purulia. They also admitted that they had no license or any authorization for carrying of I.D liquors. Accordingly, I seized (i) One blue colour Hero Glamour bike having registration No- JH 05AF 4128 (ii) Approx 20 Liters I.D liquors (Cholai) kept in two Jerakin approx 10 liters each after preparing proper seizure lists and put label on the seized articles in presence of witnesses and ½ Liters taken from each Jerakin as sample which were also duly labeled by me and also took signature of the accompanying witness on seizer lists and label as well as accused persons also. The seizure and label was done in between 18.25 hrs and 18.35 hrs & 18.45 hrs and 18.55 hrs. Thereafter, I secured arrested the accused persons namely (i) Babulal Hansda (20 Yrs) S/o- Labin Hansda (ii) Sunil Hansda (20 Yrs) S/o- Rabi Hansda both of Vill- Ratandih, PS- Balarampur, Dist-Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Informed them the grounds of arrest and also informed their relatives. The arrest was made on 20.12.2022 at 19.05 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered against the arrested accused persons namely (i) Babulal Hansda (20 Yrs) S/o- Labin Hansda (ii) Sunil Hansda (20 Yrs) S/o- Rabi Hansda both of Vill- Ratandih, PS- Balarampur, Dist- Purulia under proper section of Law.
