Sub: Complaint against Lalmohan Mahato @ Lambadhar Mahato (Male/ 49 Yrs.) S/O- Late Bhaktaranjan Mahato of Village- Sulungjuri, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Lalmohan Mahato @ Lambadhar Mahato (Male/ 49 Yrs.) S/O- Late Bhaktaranjan Mahato of Village- Sulungjuri, PS- Barabazar, Dist-Purulia and seized (i) Two white colour plastic jarecane loaded with approx 20 (Twenty) liters I.D liquors (Cholai) on which 500 ml seized as sample from said jarecane as per enclosed seizure list (ii) 06 (Six) Pcs. Of small steel Glass (iii) 02 (Two) red colour plastic mug.

l, SI Nimai Ch. Nemo of Barabazar PS do here by lodge this complaint against one Lalmohan Mahato @ Lambadhar Mahato (Male/ 49 Yrs.) S/O- Late Bhaktaranjan Mahato of Village- Sulungjuri, PS- Barabazar, Dist- Purulia. I beg to state that on 28.12.2022 myself along with C/- 1211 Chunaram Hembram & C/- 347 Manas Pathak were left for evening mobile duty vide Barabazar PS GDE No-1885 Dtd. 28.12.2022. During mobile duty at about 18.25 hrs I received an information that one person was selling I.D liquor in his house at Vill-Sulungjuri under Barabazar PS. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. At about 18.55 hrs myself along with force held raid in the dwelling house of Lalmohan Mahato @ Lambadhar Mahato at Vill-Sulunjhuri and found that he was selling ID Liquor (Cholai) from his house. Seeing the Police party buyers fled away, but we apprehended the house owner who was selling the ID Liquor. On search I found (i) Two white colour plastic jarecane loaded with approx 20 (Twenty) liters I.D liquors (Cholai) on which 500 ml seized as sample from said jarecane as per enclosed seizure list (ii) 06 (Six) Pcs. Of small steel Glass (iii) 02 (Two) red colour plastic mug. On demand, he failed to produce any valid documents / License in respect of keeping & selling I.D liquors (Cholai). On being asked he confessed his guilt and stated that he selling the I.D liquors (Cholai) from his house to the local people with intent to make his own profit. He disclosed his identity as Lalmohan Mahato @ Lambadhar Mahato (Male/ 49 Yrs.) S/O- Late Bhaktaranjan Mahato of Village- Sulungjuri, PS-Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for keeping or selling of I.D liquors (Cholai). Accordingly, I seized above noted ID Liquor with others articles after preparing proper seizure list and put label on the seized articles in presence of witnesses and on which 500 ml of I.D liquor taken as sample which were also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also. The seizure and label was done in between 19.05 hrs and 19.15 hrs. Thereafter, I arrested the accused person namely Lalmohan Mahato @ Lambadhar Mahato (Male/ 49 Yrs.) S/O- Late Bhaktaranjan Mahato of Village- Sulungjuri, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his relatives regarding the ground of arrest over mobile. The arrest was made on 28.12.2022 at 19.25 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Lalmohan Mahato @ Lambadhar Mahato (Male/ 49 Yrs.) S/O- Late Bhaktaranjan Mahato of Village- Sulungjuri, PS- Barabazar, Dist-Purulia under proper section of Law.
