- 2) The occurance of theft has been informed to me over my official contact number by Mr. Sujoy Gorai, an outsourced staff of our Branch, at around 6:12 AM on 03.12.2022 i.e.on Saturday. After receiving the information of theft, I have rushed to the Branch and reached at around 7:15 AM today i.e. on 3.12.2022 morning and on entering the Banch alongwith the staff members and in the presence of the local police we have observed the followinig conditions at the Branch:
- I) The gents toilet Window of the Branch premises was broken.
- ii) UPS and batteries alongwith wires were damaged.
- lii) CCTV camara and its system was damaged and not working.
- iv) Fire and Electrical alarm system has been disconnected and damaged;
- v) Vault Alarm system has been damaged;
- vi) Shutter gate of the Cash vault room was damaged and handle and lock system of the Main Cash Vault was damaged.
- 3)The police personnel have inspected the above items during their visit at the branch today on 03.12.2022 and gathered some evidences of the attempted theft.
