LODGEMENT OF FIR

1) I, Rakesh Roushan S/o Shaligram Prasad, posted as Branch Manager of State Bank of India, Keshargarh Branch and permanent resident of Qtr No.2712, Street 40, Sector-8C, Bokaro Steel City, Pin-827009(Jharkhand) hereby inform you that an attempt of the Bank theft has happened at our SBI, KESHARGARH (code-06796) Branch at late night on 2.12.2022 i.e. on Friday.


2) The occurrence of theft has been informed to me over my official contact number by Mr. Sujoy Gorai, an outsourced staff of our Branch, at around 6:12 AM on 03.12.2022 i.e. on Saturday. After receiving the information of theft, I have rushed to the Branch and reached at around 7:15 AM today i.e. on 3.12.2022 morning and on entering the Branch alongwith the staff members and in the presence of the local police we have observed the following conditions at the Branch :

- i) The gents toilet Window of the Branch premises was broken.
- ii) UPS and batteries alongwith wires were damaged.
- iii) CCTV camera and its system was damaged and not working.
- iv) Fire and Electrical alarm system has been disconnected and damaged;
- v) Vault Alarm system has been damaged;
- vi) Shutter gate of the Cash vault room was damaged and handle and lock system of the Main Cash Vault was damaged.

3) The police personnel have inspected the above items during their visit at the branch today on 03.12.2022 and gathered some evidences of the attempted theft.

4) In view of the above, I request you to please arrange to lodge an FIR and further investigate the matter.


