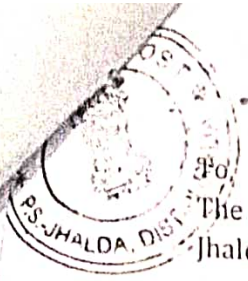

Sir,

I, SI Montaz Sheik along with force return to PS and brought under seizure One tractor bearing registration no-**JH01BZ6015 Engine No-E3305080, Chais No-T053274384 Euro41, POWERTRAC** attached with trolley loaded with sand (approx 100 cft). The fact in brief is that today (02/12/2022) I along with force namely i) C/186-Ananda Das, ii) JC/1520 Sandip Saw were performing Spl. mobile duty at Tulin OP under Jhalda PS area vide Tulin OP under Jhalda PS GDE No- 47/22 Dated- 02/12/2022 in consonance with Tulin OP under Jhalda PS CC No- 2544/22 Dated- 02/12/2022. During my Spl. mobile duty I received a credible source information that one Tractor was lifting & carrying sand illegally and coming from Subarnarekha Ghat which is situated on Subarnarekha River at Jharkhand Purulia border & coming towards Jhalda side. Subsequently, I informed you and as per your order, I placed Naka at Banglatar more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one tractor was proceeding towards Banglatar more. Consequently, we intercepted the said Tractors at Naka checking point on 02/12/2022 at about 10:15 hrs. and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police, driver of said tractor fled away leaving the tractor on road before Naka checking point. We tried to chase him but in vain. After that we searched the said Tractor for valid documents but did not find any valid documents in respect of loaded sand in the tractor. Hence I seized the tractor bearing registration no-JH01BZ6015 Engine No-E3305080, Chais No-T053274384 Euro41, POWERTRAC fitted with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter I brought the said tractor to Jhalda P.S. As such there is every reason to believe that the driver and owner of the Tractor Bearing registration no-JH01BZ6015 Engine No-E3305080, Chais No-T053274384 Euro41, POWERTRAC fitted with Trolley with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore. I pray before you that a case against the driver and owner of Tractor Bearing registration no-JH01BZ6015, Engine No-E3305080, Chais No-T053274384 Euro41, POWERTRAC fitted with Trolley may kindly be started and arrange for its investigation.
