

In producing here with the arrested accused persons namely (i) Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar of Main Road, Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia and (ii) Haraprasad Kuiry (30) S/O Phani Rhusan R Bhusan Kuiry of Vill- Purano Jhalda, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 12 (Twelve) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup styled as Onereex Cough Syrup @ 154.50/- per bottle, having 100 ml in each bottle in a White Colour Plastic bag (ii) 03 (Three) Pcs sealed bottles of Dextromethorphan Hydrobromide & Chlorpheniramine Maleate Syrup styled as Choco-DX Cough Syrup @ 101.00/- per bottle, having 100 ml in each bottle in a White Colour Plastic bag and (iii) One Black & Red colour TVS Victor Motor Cycle having Reg. No- WB 56L 8506 as mentioned above. I ASI- Sisir Kr. Gope of Jhalda PS do here by lodged a written complaint against (i) Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar of Main Road, Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia and (ii) Haraprasad Kuiry (30) S/O Phani Bhusan Kuiry of Vill-Purano Jhalda, PS-Jhalda, Dist-Purulia to the effect that today (27/12/2022) while performing Spl. mobile duty (This refers to Jhalda P.S. GDE No- 1273 Dt- 27/12/2022, vide C.C. No-3169/22 Dt- 27/12/2022) at Birsamore, I received an information from my source at about 18:35 hrs that 02 (two) persons, namely Manish Swarnakar & Haraprasad Kuiry were coming from Muri, Silli side under Jharkhand state and going towards Jhalda Town via Jhalda Ranchi Road carrying huge quantity of Cough Syrup in a white colour bag for selling clandestinely to the youth customers of Jhalda town area. On receiving this information, I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I ASI Sisir Kr. Gope along with (i) HG/1807 Shyam Sing Laya, (ii) HG/1681 Manmatha Kumar all of Jhalda PS left Birsamore immediately to work out the information. We all reached with Govt. Vehicle at Khatjuri village on Jhalda Ranchi Road at 18:55 Hrs and started Naka. Thereafter at about 19:05 hrs I found that 02 (two) persons riding in a Black & Red colour motorcycle from Jharkhand side towards Jhalda with a white colour bag as identical as I received information. Subsequently, I intercepted the motorcycle and searched and found that (i) 12 (Twelve) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup styled as Onereex Cough Syrup @ 154.50/- per bottle, having 100 ml in each bottle in a White Colour Plastic bag from exclusive possession of the accused Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar of Main Road,, Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia (ii) 03 (Three) Pcs sealed bottles of Dextromethorphan Hydrobromide & Chlorpheniramine Maleate Syrup styled as Choco-DX Cough Syrup @ 101.00/per bottle, having 100 ml in each bottle in a White Colour Plastic bag from exclusive possession of the accused Haraprasad Kuiry (30) S/O Phani Bhusan Kuiry of Vill- Purano Jhalda, PS-Jhalda, Dist-Purulia and (iii) One Black & Red colour TVS Victor Motor Cycle having Reg. No- WB 56L 8506 from the exclusive possession of the accused Haraprasad Kuiry (30) S/O Phani Bhusan Kuiry of Vill- Purano Jhalda, PS-Jhalda, Dist-Purulia. On interrogation they disclosed their identity as mentioned above and they also said that they collected these illegal cough syrup from Muri, Silli side under Jharkhand state. On demand they failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended persons and also prepared label with seal and from which 01 (one) bottle of Chlorpheniramine Maleate & Codeine Phosphate Syrup styled as Onereex Cough Syrup was kept as sample and 01 (one) bottle of Dextromethorphan Hydrobromide & Chlorpheniramine Maleate Syrup styled as Choco-DX Cough Syrup was kept as sample. They also disclosed that they were running Cough Syrup (illegal drugs) business and they were carrying the said syrup for the purpose of selling to the local youth customers. Subsequently, I arrested the accused persons namely (i) Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar of Main Road, Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia and (ii) Haraprasad Kuiry (30) S/O Phani Bhusan Kuiry of Vill- Purano Jhalda, PS-Jhalda, Dist-Purulia for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against accused persons namely (i) Manish Swarnakar (39) S/O Lt. Madan Mohan Swarnakar of Main Road, Thakurbari, Ward No-IV, PS-Jhalda, Dist-Purulia and (ii) Haraprasad Kuiry (30) S/O Phani Bhusan Kuiry of Vill- Purano Jhalda, PS-Jhalda, Dist-Purulia U/S 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.

Received on 27.12.22 at 20.45 was one stayted Thatle ADS case no - 238/22 2t 23.12.22 US- 27 of Drugs of Cosmetics Act Its 1940 and endoursed to ASS Dineben the Bouri for Its investigation.
