In producing here with 04 accused persons namely (1) Munna Singh (40 yrs) S/o-Ramababtar Singh of Vill-Salempur PS-Panapur Dist-Saran State-Bihar (Driver of Trucks No-JH01DC-3142 (2) Saddam Hossen (37yrs) S/O- Fakir Miya of vill+PS- Khalari Dist- Ranchi(JKD) (Driver of Trucks No-JH01DC-2702) (3) Pintu Kumar (42yrs) S/O- Kedar Prajapati of vill- Sallya PS- Maffusil Dist- Hazaribag (JKD) (Driver of Trucks No-JH12E-5889) (4) Basudeb Yadav (50yrs) S/O- Muni Yadav @ Mahato of vill- Beko PS- Joynagar Dist- Kodarma (JKD) (Driver of Trucks No-JH12E-8455) along with seized articles i.e. 04 (four) Trucks having Registration No- JH01DC-3142, JH01DC-2702, JH12E-5889, JH12E-8455 loaded with approx 25 TN coal per Trucks, also taken sample of 05 kg from the each trucks, to the effect that I, ASI Nisith Ch. Das along with C/-857 Chepupal Murmu, C/-1356 Rajib Kundu & C/-1387 Prabir Kr. Mishra all of Joypur PS Dist-Purulia vide CC No-4104/22 Dated-29/11/2022 were engaged in Naka checking duty at Kathaltard strategic point at Jharkhand Border on Purulia-Bokaro Pitch Road (NH-32) under Joypur PS Dist-Purulia and found the above noted Truckswere coming from Bokaro side via NH-32 towards Kathaltard on seeing the Naka Checking party stop the Trucks and found that loaded huge quantity of illegal coal, they tried to fled away, after hot chase we able to apprehended 04 persons. On being asked they disclosed their name and address as noted above. On interrogation they stated that they will sell illegal coal to the local people at coal at any place of Purulia district. On demand they failed to produce any valid papers in respect of possessing selling of coal. So it is reasonable to believe that the driver & owner of the above noted Truckscollected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted Truckstransporting coal illegally. So I seized the same under proper seizure list in between 21:45 hrs to 22:25 hrs on 29/11/2022 & label duly signed by witnesses after taking sample of 05 kg coal from per Truckss. During further interrogation he confessed his guilt as such I arrested them today 29/11/2022 at 22:35 hrs to 23:10 hrs as the accused persons is liable for prosecution U/S- 379/411/414 IPC.

I therefore pray before you, kindly lodge an FIR against the (1) owner of the Truck JH01DC-3142 and arrested accused driver Munna Singh (40 yrs) S/o-Ramababtar Singh of Vill-Salempur PS-Panapur Dist-Saran State-Bihar (Driver of Trucks No-JH01DC-3142) (2) owner of the TrucksJH01DC-2702 and arrested accused driver Saddam Hossen (37yrs) S/O- Fakir Miya of vill+PS- Khalari Dist- Ranchi(JKD) (Driver of Trucks No-JH01DC-2702) (3) owner of the TrucksJH12E-5889 and arrested accused driver Pintu Kumar (42yrs) S/O- Kedar Prajapati of vill- Sallya PS- Maffusil Dist- Hazaribag (JKD) (Driver of Trucks No-JH12E-5889) (4) owner of the TrucksJH12E-8455 and arrested accused driver Basudeb Yadav (50yrs) S/O- Muni Yadav @ Mahato of vill- Beko PS- Joynagar Dist- Kodarma (JKD) (Driver of Trucks No-JH12E-8455) as per law and arrange for its investigation.
