Sir,

In producing here with 01 accused person namely Ram Laxhan Prasad (55 yrs) S/o-Prachun Prasad of Vill-Staff Quarter, Phusro PS-Phusro Dist-Bokaro State-Jharkhand (Driver of Truck No-JH10CM-8038) along with seized articles i.e. 01 (one) Truck having Registration No- JH10CM-8038 loaded with approx 25 TN coal, also taken sample of 05 kg from the truck, to the effect that I, SI Sanjay Diger along with C/-842 Angshuman Tewary, C/-1358 Sanjib Kr. Patra & NVF/-803 Ankur Ch. Mahato all of Joypur PS Dist-Purulia vide CC No-4125/22 Dated-01/12/2022 were engaged in Naka checking duty at Kathaltard strategic point at Jharkhand Border on Purulia-Bokaro Pitch Road (NH-32) under Joypur PS Dist-Purulia and found the above noted Truck was coming from Bokaro side via NH-32 towards Kathaltard on seeing the Naka Checking party stop the Truck and found that loaded huge quantity of illegal coal, he tried to fled away, after hot chase we able to apprehended 01 person. On being asked he disclosed his name and address as noted above. On interrogation he stated that he will sell illegal coal at any place of Purulia district. On demand he failed to produce any valid papers in respect of possessing selling of coal. So it is reasonable to believe that the driver & owner of the above noted truck collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted Truck transporting coal illegally. So I seized the same under proper seizure list in between 14:15 hrs to 14:35 hrs on 01/12/2022 & label duly signed by witnesses after taking sample of 05 kg coal from the Truck. During further interrogation he confessed his guilt as such I arrested him today 01/12/2022 at 14:45 hrs as the accused person is liable for prosecution U/S-379/411/414 IPC.

I therefore pray before you, kindly lodge an FIR against the owner of the Truck JH10CM-8038 and arrested accused driver Ram Laxhan Prasad (55 yrs) S/o-Prachun Prasad of Vill-Staff Quarter, Phusro PS-Phusro Dist-Bokaro State-Jharkhand (Driver of Truck No-JH10CM-8038) as per law and arrange for its investigation.
