Sir,

In producing herewith one arrested accused person namely Mithun Sardar (30 yrs) S/o-Late Madhu Sardar of Vill- Litiyadh PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (1) One white colour polithin Jariken containing approx 09 (Nine) liter Illicit liquor (locally known as Mohulla).

I, ASI Nisith Ch Das of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 01/12/2022 at about 14:25 hrs when myself along with C/-2620 Jayanta Kapat, HG/-1717 Phanibhushan Mahato were performed Special mobile-II duty vide Joypur PS C.C. No-4131/22 date-01/12/2022, as per my source information I reached at Litiyadh Village under Joypur PS and found that the above noted accused person selling illicit liquor (Mohulla) in the dwelling house of Mithun Sardar (30 yrs) S/o-Late Madhu Sardar of Vill- Litiyadh PS-Joypur, Dist-Purulia. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 09 (nine) liter of Illicit Liquor (locally known as Mohulla) which was kept at his dwelling house. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor (Mohulla). So it is reasonable to believe that he was selling the Id liquor (Mohulla) illegally without any documents. So I seized the same under proper seizure list in between 19:35 hrs to 19:50 hrs & label duly signed by him and other available witness after taking 600 ML. as sample in a separate bottle.

During further interrogation he confessed his guilt as such I arrested him today 01/12/2022 at 19:55 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Mithun Sardar (30 yrs) S/o-Late Madhu Sardar of Vill- Litiyadh PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
