In producing herewith seized 01 (one) Blue Colour Tractor bearing Registration No-WB55B-5124 loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (20/12/2022) I, SI Dibakar Kuiri along with force 1) C/-894 Dhanajoy Mandal 2) C/-1387 Prabir Kr Mishra 3) NVF/-817 Bhubaneswar Mahato all of Joypur P.S were performing Evening Mobile duty vide Joypur PS CC No-4354/22 Date-20/12/2022. During my mobile duty at about 16:45 hrs received a credible source information that one tractor loaded with sand is coming from Baragram side under Joypur PS, I along with force reached at Manakchita more under Joypur PS and found that one Blue Colour Tractor bearing Registration No- WB55B-5124 loaded with sand (100 CFT approx). On seeing the Police party at Manakchita more under Joypur PS, the driver of the said tractor fled away leaving the tractor standing beside the village more. We rushed to the tractor and searched the said tractor and found that the tractor loaded with sand and also searched surrounding the P.O but I did not trace out the driver / owner of the said tractor. Hence I seized the tractor bearing Registration No-WB55B-5124 loaded with sand (100 CFT approx) under proper seizure list in between 17:35 hrs to 17:45 hrs in presence of available witnesses and I brought the said Tractor to Joypur P.S. As such there is every reason to believe that the driver and owner of the said tractor is dealing with sand illegally and transporting with ill motive without any valid document.

Hence, they are liable for offence punishable U/S-379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of the said Tractor may kindly be started and arrange for its investigation
