Sub: To lodge FIR against owner and driver of seized tractor i.e. one Swaraj 834 XM (Blue Colour) Tractor having RGD No- W~~N~~ 81/1283, Engine, No -331008/SYF02940, Chassis No - WSTF24428150267 along with trolley (without number plate) loaded with sand approx 70 - 80 Cft and 02 (Two) Belcha, 02 (Two) Dhama.

Respected Sir,

In producing herewith 01 (One) seized tractor i.e. one Swaraj 834 XM (Blue Colour) Tractor having RGD NO- W~~N~~ 81/1283, Engine, No -331008/SYF02940, Chassis No - WSTF24428150267 along with trolley (without number plate) loaded with sand approx 70 - 80 Cft and 02 (Two) Belcha, 02 (Two) Dhama.

The nub of the fact in a nutshell is that today on 06.12.22 at 09.15 hrs. I ASI Shibaram Bauri of Kashipur PS along with (i) C/416 Sahadeb Hansda and (ii) C/2988 Baidyanath Praharaj both of Kashipur PS, Dist - Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 242 Dtd - 06.12.2022 and C.C No. 3209/22 Dtd. 06.12.2022. During my mobile duty, I received a tip off at 13.45 hrs. that some persons were loading one tractor with sand from the river bed of Darkeswar River near Rajowar Para Samsan Ghat, Khahipur under Kashipur P.S., Dist- Purulia. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolley) at Darkeswar River and fled away from the spot. We rushed to the Tractor and detained the said tractor. We searched the said tractor and found that the tractor was loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending Tractor. Hence, I seized the above noted tractor along with trolley loaded with sand and other articles in between 15.15 hrs to 15.45 hrs and brought the said seized articles to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.


Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
