FIR LODGE FOR CARRYING UNAUTHORISED SAND

With reference to the above, this is to inform that as per the report received from the Kenda Police Station, a vehicle loaded with unauthorised sand was caught on Kenda-Chandatiri Road near Kenda Forest Office on 27.12.2022 at around 18.05 pm without any valid documents from the Mines and Minerals Department and was detained by them for verification.

On receiving the information, the Revenue Officer of this block Sonam Rumba S/o Phurba Rumba PO+PS+Village Sonada, Dist Darjeeling was asked to visit the Police Station and was found that the driver of the vehicle failed to produce any valid challan.

The details are as follows:

- One Blue Coloured 3037 New Holland Plus 39HP tractor having Registration No WB/55A/7980 attached with trolley loaded with sand approx. 100 cft.
- The name of the driver is Ajoy @ Laden Besra S/o Haburam Besra, Village Chandatiri, PS Kenda, Dist Purulia
- As per the driver, the truck was loaded from Kansabati/Kansai Riverbed with the connivance, conspiracy and direct help from the following persons, and that the theft was being done continuously and frequently from this this riverbed.
 - i. Dilip Kumar Hansda, S/o Kalipada Hansda, Village Kalipur, PS Hura, Dist Purulia
 - ii. Chittaranjan @ Ajit Mahato S/o Narendranath Mahato, Village Chandatiri, PS Kenda, Dist Purulia
 - iii. Sujit Kumar Sarkar S/o Gurupada Sarkar, Village Jambaid, PS Kenda, District Purulia

Hence, this activity falls under the illegal activities under Section 21 of Mines and Minerals (Development and Regulations) Act 1957.

Therefore, you are requested to lodge an FIR against the above persons for theft of sand from Kansabati riverbed and thereby making conspiracy and direct help of the above persons.

This is for your kind information and taking necessary action against the above-mentioned persons.
