In producing here with one accused person Arjun Chaudhuri (55 Yrs.) S/O Lt- Dhani Chaudhuri of village Salaiyakla, PO- Fatepur, PS- Fatepur, Dist- Gaya, Bihar A/P- Samda PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 12 (Twelve) Ltrs. ID liquor within a Plastic Jarikane
- (2) 10 pieces plastic glasses.

I S.I. Soumen Kr. Panda of Manbazar PS do here by lodged a complaint against accused namely Arjun Chaudhuri (55 Yrs.)
