Sir,
In producing here with one accused person Arjun Chaudhuri (55 Yrs.) S/O Lt- Dhani Chaudhuri of village Salaiyakla, PO- Fatepur, PS- Fatepur, Dist- Gaya, Bihar A/P- Samda PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 12 (Twelve) Ltrs. ID liquor within a Plastic Jarikane
- (2) 10 pieces plastic glasses.

I S.I. Soumen Kr. Panda of Manbazar PS do here by lodged a complaint against accused namely Arjun Chaudhuri (55 Yrs.) S/O Lt- Dhani Chaudhuri of village Salaiyakla, PO- Fatepur, PS- Fatepur, Dist- Gaya, Bihar A/P- Samda PS- Manbazar, Dist- Purulia to the effect that today (01.12.2022) at 16:05 hrs. I received a telephonic information from a reliable source that one Arjun Chaudhuri (55 Yrs.) S/O Lt- Dhani Chaudhuri of village Salaiyakla, PO- Fatepur, PS- Fatepur, Dist- Gaya, Bihar A/P- Samda PS- Manbazar, Dist- Purulia was stocked ID liquor illegally at Samda village morh and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/441 Santo Das and HG/1419 Santanu Dutta rushed to the spot for raid by Govt. vehicle. At about 16:25 hrs. myself along with force reached at Samda morh and held raid in the Temporarily house of Arjun Chaudhuri at Samda morh and found that the owner selling ID liquor at his temporarily house and Seeing the police party some persons fled away and said Arjun Chaudhuri tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Arjun Chaudhuri (55 Yrs.) S/O Lt- Dhani Chaudhuri of village Salaiyakla, PO- Fatepur, PS- Fatepur, Dist- Gaya, Bihar A/P- Samda PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
