Sir,

In producing herewith one Tractor fitted with approx 100cft sand loaded Trolley as per seizure list, having Reg. No- WB 55B/5376 of the engine. I, A.S.I. Sambal Kr. Singh along with C/460 Nirmalendu Singha Mahapatra and NVF/697 Debendranath Bauri Vide Manbazer P.S C.C No 4180/22 and GDE No- 29 dt- 01.12.2022 was engaged for evening mobile duty. Then at 16:05 hrs received a credible source information that the above noted vehicle (Tractor) is transporting sand illegally near Mouzadih village under Manbazar PS, Dist- Purulia. Subsequently myself along with force left to work out the information. When we reached near Mouzadih village found the said Tractor was coming from Kansai river side. Seeing the police party, driver of the said vehicle (Tractor) fled away keeping the Tractor on the road. We chased him but could not able to intercept. Searched the Tractor and found that the registration no. of Tractor is WB 55B/ 5376 and the Tractor is loaded with 100 cft sand with attached trolley. Then I searched the Tractor for any valid document regarding the loaded sand as well as the Tractor. But no any documents found.

I hold a local enquiry and found that Bhajahari Mahato S/O Lt- Bhutnath Mahato Of Mouzadih village, PS- Manbazar, Dist- Purulia is connected with transportation sand illegally. Hence I seized the above noted tractor JOHN DEERE – 5105 having registration no- WB 55B/5376 (Coloured Deep Green) with trolley (without registration no.) loaded with approx (100 cft) sand.

There is every reason to believe that the driver and owner of the above-mentioned Tractor and Bhajahari Mahato S/O Lt- Bhutnath Mahato Of Mouzadih village, PS- Manbazar, Dist- Purulia with ill motive are transporting sand illegally without any valid document in support of carrying sand and they habitually deal with the business of stolen sand in a clandestine manner since few days. Hence, I brought the said Tractor loaded with sand trolley to Manbazar PS for legal action.

Therefore, I pray before you that a case may kindly be started against the driver, owner and Bhajahari Mahato S/O Lt- Bhutnath Mahato Of Mouzadih village, PS- Manbazar, Dist- Purulia of the above-mentioned Tractor.
