Sir.

In producing herewith one arrested accused person namely Siraj Ansary (52 Years) S/O- Lt. Sabrati Ansary of Vill-Keliasota, PO-Chalmara, PS-Neturia, Dist-Purulia along with one seized tractor bearing registration No- JH 10CE/9392 with trolley loaded with 02 MT (Approx) steam coal and approx 160 MT steam coal, Dhama (Bucket)-08, Belcha-03 seized from the back side bushy area of the coal depo of Siraj Ansary styled as "Shersha Baba Coal Traders" situated at Keliasota, Chalmara, PS-Neturia, Dist-Purulia in hidden condition in bushy area, do hereby lodge a complaint to the effect that on 30.11.2022 I, SI Banshi Lal Mahato, along with C/1319 Soumen Koley, C/564 Prasad Majhi and NVF/711 Sunil Singh all are of Neturia PS were engaged in PS area mobile duty vide Neturia PS GDE No- 1321 Dt. 30.11.2022 & CC No- 3812/22 Dt. 30.11.22. In course of PS area mobile duty at about 10:45 hrs after receiving secret source information of stocking of huge quantity of steam coal near the Depo of Siraj Ansary situated at Kelisota, PS-Neturia, Dist-Purulia. Shared the information to my superior and after receiving your kind order myself along with force left for Keliasota to work out the information. Being reached there at 11:15 hrs and after search at the bushy area behind the coal depo of Siraj Ansary styled as "Shersha Baba Coal Traders" and found huge quantity of steam coal was stocked there in hidden condition in bushy area and one tractor having registration No-JH 10CE/9392 along with trolley loaded with steam coal near coal depo of Siraj Ansary. The owner of coal Depo Siraj Ansary (52 Years) S/O- Lt. Sabrati Ansary of Vill-Keliasota, PO-Chalmara, PS-Neturia, Dist-Purulia has been asked to produce any valid document in support of stock coal and also loaded coal in tractor having registration No- JH 10CE/9392 but he failed to produce any valid documents. He confessed that he stocked and loaded steam coal in tractor having No- JH 10CE/9392 illegally after procuring it by any clandestine manner.

There is strong reason to believe that the owner of coal Depo Siraj Ansary, owner and driver of the tractor having No- JH 10CE/9392 have procured the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same coal in a clandestine manner to

different places knowing it to be stolen, as per their regular practice.

Accordingly, I seized one tractor bearing registration No- JH 10CE/9392 with trolley loaded with 02 MT (Approx) steam coal and approx 160 MT steam coal, Dhama (Bucket)-08, Belcha-03 seized from the back side of the coal depo of Siraj Ansary under proper seizure list duly signed by witnesses and necessary arrangement has been made for shifting the steam coal to Neturia PS with the help of JCB, dumper provided by Khan Transport, Inanpur, PS-Neturia, Dist-Purulia. After seizure arrested owner of the coal depo namely Siraj Ansary (52 Years) S/O- Lt. Sabrati Ansary of Vill-Keliasota, PO-Chalmara, PS-Neturia, Dist-Purulia after maintaining all formalities of arrest rule. On interrogation he confessed that he along his son Sabir Ansary, owner and driver of the tractor having No- JH 10CE/9392 are running such type of illegal business since long.

Under the above circumstances a specific case may kindly be started against (1) Siraj Ansary (52 Years) S/O- Lt. Sabrati Ansary of Vill-Keliasota, PO-Chalmara, PS-Neturia, Dist-Purulia (2) Sabir Ansary S/O-Siraj Ansary of Vill-Keliasota, PO-Chalmara, PS-Neturia, Dist-Purulia (3) Owner of the seized vehicle No-JH

10CE/9392 and (4) Driver of the seized vehicle No- JH 10CE/9392 under proper section of law.
