Sub:- Complain for starting a specific case .

Sir,

In producing herewith the seized dumper having registration No- WB 41H/0123 loaded with sand approx 400 Cft under proper seizure list. I beg to submit that I, ASI Rajkumar Goswami, along with C/1302 Radha Gobinda Dhibar, C/399 Kartik Mura and C/1319 Soumen Koley all are of Neturia PS were performing night mobile cum Naka duty vide Neturia PS GD No- 351 Dt. 07.12.22 & CC No- 3889/22 Dt. 07.12.22 at D. Ghat and on 08.12.2022 at about 04:15 hrs received a credible source information that one dumper loaded with illegal sand coming from Sarbari side towards D. Ghat side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started Naka at D. Ghat and at about 04:25 hrs found that above noted dumper was coming from Sarbari side and suddenly the dumper stopped approx 75/80 meter away from us and one person seems to be the driver of the vehicle got down from the vehicle and started running towards the darkness. We chased to apprehend the person but in spite of hot chase he managed to flee away. Then we searched the vehicle and found that the vehicle (Dumper) having registration No- WB 41H/0123 has been loaded with sand approx 400 Cft.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Barakar side knowing it to be stolen.

Accordingly, I seized the Dumper bearing No WB 41H/0123 loaded with sand approx 400 C.Ft. under proper seizure list duly signed by witnesses. So, the driver and registered owner of the dumper have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver of dumper No- WB 41H/0123 and registered owner the dumper No. WB 41H/0123 U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
