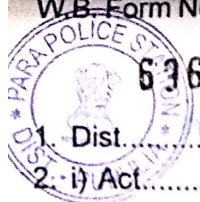

Sir,

In producing herewith seized coal i.e. 298.310 M. ton Coal out of which 26.530 M. Ton is Soft Coke (which is generally used for domestic cooking purpose) along with proper seizure list and all connected papers.

I beg to report that on 12.12.2022 at 10.25 hrs. O/C Para PS received a source information that a huge amount of illegal Coal has been damped in Vindhyachal Domestic Coke Manufacturing Depot near Rukni morh beside Raghunathpur - Chandankeyari main road (SH-8) under Para PS, Dist- Purulia. Accordingly, he direct me to enquire into the matter and as per direction of O/C Para P.S. myself along with C/351 Kanailal Bouri, C/2993 Haru Chhutar and NVF/867 Shankar Ch. Dey reached at the spot i.e. Vindhyachal Domestic Coke Manufacturing Depot near Rukni morh beside Raghunathpur - Chandankeyari main road (SH-8) under Para PS, Dist- Purulia (vide Para PS GDE No-501 dtd.12.12.2022 and C.C. No-3947, dtd.12.12.2022) at about 11.35 hrs. and found a huge amount of Coal has been damped there. The place has been covered by boundary wall having an concrete Chimni. This is a soft coke manufacturing factory. Accordingly, I have waited there for a long time but no one turn up there or none have not showed any valid documents in respect of said damped Coal. In between this time, I have conducted a local enquiry from where came to know that one Dipak Kr. Yadav S/O- Ganesh Yadav of Bank more Katras rd Gope Patha, PS-Bank more , Jharkhand is the owner of said Vindhyachal Domestic Coke Manufacturing Depot near Rukni morh beside Raghunathpur - Chandankeyari main road (SH-8) under Para PS, Dist- Purulia. Finding no alternative way, I hired six (06) Hyva (Dumpers ) arranged bearing Reg. No. i) WB-55A/3436, ii) WB-55A/4653, iii) WB-55A/1170, iv) JH10AT/9377, v) WB-55A/1169 and vi) WB-55A/6911 for transportation of coal after seized as there was sufficient reason to believe that those seized coal was procured by means of theft or by any fraudulently means. Thereafter, the said coal loaded above noted Dumpers carried those seized coal up to P.S. for several times after being measure it and found total amount of Coal 298.310 M. ton has been seized out of which 271.780 M. Ton Coal & 26.530 M. Ton is Soft Coke. I seized the said 298.310 M. ton Coal in which 271.780 M. Ton Coal & 26.530 M. Ton is Soft Coke and 17 copies weighing slip after preparing proper seizure list duly singed by the police party as no one was agreed to sign in the seizure list. Approx 05(five) Kg of Coal & Approx 05(five) Kg Soft Coke has been sealed labelled as sample coal from major contraband.

Hence I pray that a specific case may kindly be started against Dipak Kr. Yadav, Owner of the Vindhyachal Domestic Coke Manufacturing Depot along with his associates.
