Sir,

In producing herewith the following Trucks loaded with coal Bearing Regd. No-1) WB 55A/4396, 2) WB 55A/8070, 3) WB 81/0661 loaded with coal approx 25 M.T each. with proper seizure list duly singed by the witnesses. I ASI Rajib Kr. Tewari of Para PS do here by lodged a complaint to the effect that today i.e. on 22.12.2022 at 01.25 hrs O/C Para PS received a secret source information that the above noted Trucks loaded with coal will come from Jhapra side which has been procured by means of theft or fraudulent means from somewhere. This refers to Para P.S. GDE No. 926, dt. 22.12.2022 and O/C Para PS instructed me to work out the information immediately as I was engaged in Spl. Mobile duty.

Accordingly, myself along with force C/365 Chandi Charan Pandey, C/57 Bisweswar Buari, C/3010 Kanchan Majhi all of Para PS waited in a safe place at Jhapra - Dubra pitch road near Gurguria More under Para PS & keeping our PS vehicle in a safe distance. At about 02.25 hrs. we found that the above noted Trucks Bearing Regd. No- 1) WB 55A/4396, 2) WB 55A/8070, 3) WB 81/0661 is coming from Jhapra side. Accordingly, we are the police personnel in uniform and intercepted the those trucks loaded with coal, But somehow the drivers managed to escape after parking their vehicle(trucks) near Gurguria More. I searched the parked vehicles (trucks) and found coal loaded in those trucks but no documents, valid papers / challan in respect of said loaded Coal, could be found. I waited for longtime for any persons who came and claimed for those coal loaded trucks. But no one turned up before me. So, there was a strong reason to believe that the owner of the above noted Trucks, drivers along with associates with others procured the coal by means theft of any other fraudulent means and were transporting the same for some wrongful gain. As such, I seized the said Trucks as well as the said loaded Coal approx 25 M.T each and 5 Kgs coal seized from each trucks from the main contraband with proper seizure list duly signed by the witnesses. Due to dead night there was no public witness was available.

Therefore, I pray before you to initiate a specific case against the owners, drivers of the Trucks bearing Regd. No- 1) WB 55A/4396, 2) WB 55A/8070, 3) WB 81/0661 and other associates as per proper section of law.
