

Sub:-Prayer for lodging an FIR

Respected Sir

With due respect I beg to state that I SI Srikanta Mula presently posted at this PS would like to note here that on 29.10.2022 I was endorsed for holding enquiry in c/w Purulia(M) PS U/D Case No-22/2019 Dtd-23.11.2019.After taking charge of enquiry I perused papers(inquest form, dead body challan, all concerned message copy, PM report) handed over to me and learnt from the papers that one U/D Case was started at Purulia(M) PS vide U/D case No-22/2019 Dtd-23.11.2019 over the written information of Ajit Kr Mahato. s/o-Gavinda Mahato of vill-Chakra, PS-Purulia(M),Dist-Purulia over the dead body of one unknown female aged about 20 years and the then SI Sastipada Jhariat formerly posted at Purulia(M)PS enquired the U/D Case.

After perusal of PM report vide Purulia Deben Mahato Sadar Hospital PM no-1028/2019 Dd-23.11.2019 & it was found that the cause of death was due to the effect of injuries ante mortem in nature. I examined the informant and learnt that on 23.11.2019 at about 04.30 hrs he found one female dead body aged about 20 yrs lying near Chakra more on Purulia-Ranchi road. He also stated that he primarily believed that the cause of death was due to road traffic accident.

I also enquired at local area from every angle to identify the dead body but till date it has not been identified. After local inquiry it is learnt that one unknown vehicle rushly coming from Jhalda side dashed the said women on 23.11.2019 at about 04.00 hrs while walking through left side of Ranchi-Purulia road and vehicle fled away from the spot and as result she expired on the spot due to injuries. I would like to note here that during local inquiry it is found that deceased used to roam aimlessly at that area and she had no shelter.

I therefore pray before your honour that a specific case may kindly be started under proper section of law and arrange for its investigation.
