Sub:-Prayer for starting a specific case against namely Sanjay Mahato(34),s/o-Sasanka Mahato of vill-Bhuiandih, PS-Purulia(M) , Dist-Purulia.

Respected Sir,

In producing herewith one accused person namely Sanjay Mahato(34),s/o-Sasanka Mahati of vill-Bhuiandih, PS-Purulia(M),Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

1) Sixteen (16) sealed plastic bottles containing 600 ml CS liquor each and labelled with DILKHUSH.

I SI Abhijit Singha of this PS do hereby lodge this complaint regarding that today (14.12.2022) at about 12.05 hrs during my spl raid duty at Kustaur more received a source information over telephone that the above noted accused person has been selling CS liquor illegally and clandestinely at his own line hotel (JOY BHOLE) at Golkunda more under Purulia(M) PS. On receiving the reliable source information I communicated with I/C Purulia(M) PS over telephone and as per his instruction I along with C/297-Apurba Pandey, C/154-Rajib Nag both of Purulia(M) PS rushed to the spot to work out the information. On arriving to the spot at 12.15 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused in the seizure list and the label in between 12.20 hrs to 12.35 hrs. One bottle 600 ml liquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness & accused on seizure list and label. After this I arrested that accused person Sanjay Mahato(34),s/o-Sasanka Mahato of vill-Bhuiandih, PS-Purulia(M) , Dist-Purulia at 12.45 hrs after preparing proper memo of arrest.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
