- 2) Dibakar Mahato (37 yrs.), S/o Lt. Joychand Mahato both of Village Malthore, P.S.- Purulia (M.).
- 3) Kailash Chandra Mahato (42 yrs.) S/o Lt. Surendranath Mahato and
- 4) Dukkha Bhanjan Mahato (33 Yrs.) S/o Lt. Ludhu Mahato both of Village Golkunda, P.S.- Purulia (M.). and some others.

They are creating agitation and provoking the people so that the meeting could not be held anyway. They are assaulting myself by provoking the local women, heckling me, pushing me and are using filthy languages to dishonor me. Therefore, you are hereby requested to take necessary action as per law.
