Respected Sir,

In producing herewith the following arrested accused persons namely 1) Dineshed Mahato(39),s/o-Sasadhar Mahato,(2)Santiram Mahato(25), s/o-Lt Naresh Mahato, (3)Bikash Mahato(30), s/o-Ashoke Mahato,(04) Sarathi Mahato(35), W/O-Dineshed Mahato, all of vill-Muturdih, PS-Purulia(M), Dist-Purulia under arrest and seized articles under proper seizure list:

i) Three (03) stones seized from Dinesh Mahato, Bikash Mahato, Santiram Mahato

ii) One bamboo stick seized from Sarathi Mahato

I would like to state here that today(30.12.2022) I PSI Soumik Acharya and C/2498-Ranjan Kr Samanta, C/699-Biswajit Banerjee were engaged in day mobile duty at Hura road vide CC No-4530/22 Dtd-30.12.2022 and at 10:05 hrs received an information that one Tiloka Mahato, w/o-Lt Parikhit Mahato(AWW), Geeta Kumari Rajak, w/o-Ditish Rajak (Helper), Jayashree Mahato, w/o-Pranab Mahato (Asha Worker) were was restrained / detained in ICDS centre room at Muturdih village by lock and key by approx 70/80 males and females of Muturdih villagers regarding the PMAY scheme and tried to assault them. After that I along with force went to work out the information as per kind order of I/C Purulia(M)PS by Govt. vehicle vide its Reg. No- WB24AM/7921. After arrival at Muturdih village at 10.25 hrs near the house of Bhakti Bilasi Mahato, we found unruly mob with huge gathering including female members there and restrained Tiloka Mahato, w/o-Lt Parikhit Mahato(AWW), Geeta Kumari Rajak, w/o-Ditish Rajak (Helper), Jayashree Mahato, w/o-Pranab Mahato (Asha Worker) inside a house(ICDS Centre) by lock and key, surrounded by agitated huge unruly mob with lathi & stone in their hands. We the Police party tried our label best to manage the situation, also requested them to maintain peace of the area but they did not pay any heed of our words and also used abusive languages aiming against us. In the main time the representative of BDO office staff namely Shri Chanchal Kr Mandal Jt BDO Purulia II block reached there but the mob became more furious regarding PMAY scheme. We the Police party again requested to the agitated mob to stop but they did not pay any heed. Then after strong effort we could free the detained persons from the room by breaking lock & key and when we started to move with the victims getting into our vehicle, then all the mob became more furious being excited and instigated also started shouting মার শালা পুলিশকে, ঘরে ঢুকিয়ে আগুন জ্বালিয়ে দে and the mob obstructed our road by placing big stone & wooden log on road. I informed the matter to I/C Purulia (M)PS and as we were re-enforced by few officers & force immediately, then we all approached to move and we loudly commanded the said unlawful assembly to disperse the road. But they did not pay heed. Finding no alternative way, in order to prevent any mischief and to save the life of Police personnel as well as safe the life of recovered persons and under the command of superior we resorted to push to disperse. Thereafter all the unruly mob dispersed from the spot and we were able to apprehend above noted four (04) involved persons from the spot with stone on their hands. After interrogation they confessed their guilty before us and they confessed that they along with following persons are involved in conspiracy. I seized the above mentioned articles under proper seizure list in between 12.05 hrs & 12.15 hrs and then I arrested them under proper arrest memo and informed them the ground of arrest and all formalities followed and also maintaining decency of female arrested persons in

between 12.15 hrs & 12.45 hrs. From the statement of arrested accused persons and from our source and videos taken during crime, it is clear that the following persons namely 1) Dinesh & Mahato(), \$\(\) o-Sasadhar Mahato, (2)Santiram Mahato, \$\(\) o-Lt Naresh Mahato, (3)Bikash Mahato, \$\(\) o-Ashoke Mahato, (4) Basanta Mahato, \$\(\) o-Nanigopal Mahatoand, (5)Fatik Mahato, \$\(\) o-Adalot Mahato, (06) Nishikanta Mahato, \$\(\) o-Sasadhar Mahato, (07)Sarathi Mahato, \$\(\) o-Dinesh Mahato, (08)Susmita Mahato, \$\(\) o-Santiram Mahato, (09)Chandana Mahato, \$\(\) w/o-Sudhir Mahato, (10) Golapi Mahato, \$\(\) o-Nishikanta Mahato, (11)Sulochona Mahato, \$\(\) w/o-Sudhir Mahato, (12)Kajoli Mahato, \$\(\) w/o-Kamdev Mahato, (13)Mousumi Mahato, \$\(\) w/o-Bidhan Mahato, (14)Surodhani Mahato, \$\(\) w/o-Bhaktibilsh Mahato, (15)Kamala Mahato, \$\(\) w/o-Gorachand Mahato, (16)Aparna Mahato, \$\(\) w/o-Sunirmal Mahato, (17)Ramala Mahato, \$\(\) w/o-Suresh Mahato, (18)Bhadu Mahato, \$\(\) w/o-Fatik Mahato, all of vill-Muturdih, PS-Purulia(M), Dist-Purulia along with \$\(\) 50/60 other villagers of Muturdih village are fully involved in this crime who obstructed the detailed officers and force in discharging of public function with ulterior motives.

I therefore pray before your honour that a specific case may kindly be started against the above noted arrested and other involved accused persons under proper section of law and arrange for its investigation.
