In producing herewith two arrested aced. Persons namely (1) Tanveer Husain, (28 Years), S/O- Sher Khan, of 166 Berasia Road, Near Shareef Kha Ki Masjid, Fiza Colony, Huzur, P.S- Nishatpura, Dist-Bhopal, State- Madhya Pradesh. And (2) Ali Raza, (28 Years), S/O- Rayat Khan, House No-13, Aman Colony, Karond, Huzur, P.S- Nishatpura, Dist- Bhopal, State- Madhya Pradesh along with seized articles i.e (1) 02 pieces of Two Thousand Rupee (Re-2000/-) currency notes (2) 01 piece of five hundred Rupee (Re-500/-) currency note and (3) 01 piece of two hundred Rupee (Re-200/-) currency note (All notes assumed to be fake) under proper seizure list.

I ASI Raju Mukherjee of Purulia (T) PS lodged this complaint against the above noted accused persons to the effect that today on 08.12.22 at 08:25 hrs while I engaged in day Mobile Duty vide GDE No- 452, and CC No- 3258/22, Dated-08.12.22 received a secret source information that two persons of Bhopal, Madhya Pradesh are presently staying at Hotel Rupashi Bangla for dealing with FICN at Purulia area to circulate FICN in a business deal. On receipt of this information I brought to the knowledge of I.C Purulia (T) P.S. As per his direction it was decided that myself along with ASI Sk. Abdul Jamshed ,C/ 236 Ram Chandra Gorai, C/1098 Tarani Sing Sardar, NVF 246 Arjun Tantubai, NVF 188 Arup Mahato all of Purulia (T) P.S will go to that place. Accordingly at about 08:35 hours left to work out information. At about 08.45 hrs myself along with officer and force reached at Rupashi Bangla Hotel and found two persons of Bhopal, Madhya Pradesh staying at that Hotel Rupashi Bangla. On being asked they start different statement in different time which was suspicious to me. After a long interrogation they disclosed their identity as (1) Tanveer Husain, (28 Years), S/O- Sher Khan, of 166 Berasia Road, Near Shareef Kha Ki Masjid, Fiza Colony, Huzur, P.S- Nishatpura, Dist- Bhopal, State- Madhya Pradesh. and (2) Ali Raza, (28 Years), S/O- Rayat Khan, House No-13, Aman Colony, Karond, Huzur, P.S- Nishatpura, Dist-Bhopal, State- Madhya Pradesh. During search on their in presence of witnesses seized (1) 02 pieces of Two Thousand Rupee (Re-2000/-) currency notes (2) 01 piece of five hundred Rupee (Re-500/-) currency note and (3) 01 piece of two hundred Rupee (Re-200/-) currency note (All notes assumed to be fake) which were kept in their left side shirt pocket. On being asked about those currency notes (assumed in be faked) they could not give any satisfy answer in respect of possession of such notes. At last they confessed that they deals with Fake currency notes and they came to Purulia to show the sample note to their other agents, after conformation of deal they supply the bulk amount of fake currency. Some persons are involve in the trafficking of forged currency notes in Purulia district to dispose the same to another who will transform the fake currency as genuine. They confessed that they have been involved in the racket.

Then I seized (1) 02 pieces of Two Thousand Rupee (Re-2000/-) currency notes (2) 01 piece of five hundred Rupee (Re-500/-) currency note and (3) 01 piece of two hundred Rupee (Re-200/-) currency note (All notes assumed to be fake) under proper seizure list in presence of the available witnesses of raid parties as Alamat of the case. Copy of the seizure list was given to the accused persons acknowledging in the seizure list. After seizure all the seized articles were sealed and labeled properly in presence of the witnesses and accused persons as well. Seizure, Labeling were made in between 09.15 hr and 09.35 hr.

Then I arrested the both the persons informing the ground of arrest by issuing memo of arrest in between 09. 45 hr and 09.50 hr. After arrest we moved nearby areas in search of the other agents who had a plan buy and to circulate FICNs from them. But we could not locate them; probably they had got the smell of police raid.

Therefore I Pray before you to use US 489A/489B/489C/120B IPC may kindly be started against (1) Tanveer Husain, (28 Years), S/O- Sher Khan, of 166 Berasia Road, Near Shareef Kha Ki Masjid, Fiza Colony, Huzur, P.S- Nishatpura, Dist- Bhopal, State- Madhya Pradesh. And (2) Ali Raza, (28 Years), S/O-Rayat Khan, House No-13, Aman Colony, Karond, Huzur, P.S- Nishatpura, Dist- Bhopal, State- Madhya Pradesh & other associates.
