Sub: Prayer for lodging F.I.R. against arrested accused person namely Subhas Mahato (48 yrs) S/O-Kamal Mahato of Telkalpara, Mahato Para, Ward No-11, Purulia, PS- Purulia (T), Dist- Purulia

Sir,

In producing herewith one arrested accused person namely Subhas Mahato (48 yrs) S/O- Kamal Mahato of Telkalpara, Mahato Para, Ward No-11, Purulia, PS- Purulia (T), Dist- Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

(1) 15 (Fifteen) litter's of ID liquor contain in 01 white colour Plastic Jarican.

(2) 50 (Fifty) pieces plastic glass.

(3) 01 (One) blue colour Plastic Mug.

(4) 375 ml ID liquor collected from above 15 (Fifteen) liters ID liquor as sample.

I, ASI Malay Sarkar, beg to report that while I was performing Evening mobile duty vide Purulia (T) PS GDE No- 900 dated 14.12.22, at about 19:45 hrs received a secret telephonic information from source that one person namely Subhas Mahato (48 yrs) S/O- Kamal Mahato of Telkalpara, Mahato Para, Ward No-11, Purulia, PS- Purulia (T), Dist- Purulia is selling ID liquor illegally at his dwelling house.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of NVF/892 Rup Sing Besra and HG/1574 Swapan Kr. Mahato all of Purulia (T) PS proceeded to work out the information.

At 20:05 hrs. we reached at Telkalpara, Mahato Para keeping our Govt. vehicle at a reasonable distance we proceeded towards his dwelling house near Mahato Para at Telkalpara as informed by the source and found that the said person was selling ID liquor as noted above to some persons and some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase one of them could be nabbed. On interrogation he confessed his guilt as he was selling ID liquor as noted above to the locals without having any authority since long. He also failed to produce any license in favour of selling, keeping or possessing ID liquor and the said person disclosed his identity as noted above. On search of the house we found 15 (Fifteen) litter's of ID liquor contain in 01 white colour Plastic Jarican, 50 (Fifty) pieces plastic glass & 01 (One) blue colour Plastic Mug. As such at about 20:25 hrs to 20:45 hrs I seized the above noted ID liquor under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrested him at 20:55 hrs observing all the formalities as the said person committed an offence which attracts sec. 46 (A) (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
