In producing here with 05 (Five) arrested accused persons namely (1) Padarath Kumar Yadav, (27 Years) S/O- Bhagabat Yadav , Village- Pekra, PO+ P.S- Singhia, Dist- Samastipur, Bihar driver of the seized vehicle no. OD05AA2745 (2) Laxmidhar Patra (36 Years), S/O- Haluri Patra, Village- Nuasahi Begunia, PO- Begunia, P.S- Begunia, Dist- Khordha, Odisha driver of the seized vehicle no. OD05AZ2745 (3) Prashanta Kumar Pradhan, (41 Years) S/O- Braja Bandhu Pradhan, of Village +Post- Gadasahi, P.S- Kanasa, Dist- Puri, Odisha. driver of the seized vehicle no OR 05AP 2745, (4) Jayprakash Biswal, (30 Years), S/O- Prafulla Biswal, Village- Bani Kunda, PO- Pankapal, P.S- Kujanga, Dist- Jagatsinghapur, Odisha, driver of the seized vehicle no. OD 29E2878, (5) Ramesh Chandra Sahoo, S/O- Bhagaban Sahoo of Bhagabanpur, PO- Shasanipara, P.S- Patkura, Dist- Kendrapara, Odisha, driver of the seized vehicle no OD 04K 7283 along with 05 (Five) seized vehicle No (1) One truck having regd no- OD05AA2745 loaded with approx 28 Ton Coal, and also taken sample of 05 kg coal from the truck, (2) One truck having regd no- OD05AZ2745 loaded with approx 27 Ton Coal, and also taken sample of 05 kg coal from the truck, (3) One truck having regd no- OR 05AP 2745 loaded with approx 23 Ton Coal, and also taken sample of 05 kg coal from the truck (4) One truck having regd no- OD 29E 2878 loaded with approx 29 Ton Coal, and also taken sample of 05 kg coal from the truck, (5) One truck having regd no- OD 04K 7283 loaded with approx 20 Ton Coal, and also taken sample of 05 kg coal from the truck . to the effect that I SI Jayanta Maji along with C/586 Bholanath Dey, C/236 Ram Chandra Gorai , all are of Purulia (T) PS were engage in night mobile duty as well as Spl. Naka duty at Telkalpara Naka Point on Purulia-Bankura road (NH60A) vide Purulia (T) PS CC No- 3313/22 dated 14.12.2022 and PS GDE No 926 dated 14.12.2022 and at about 23:35 hrs stopped five (05) vehicle loaded with coal coming from Telkolpara Fly over side & detained them , driver named above. I contacted with my I/C and informed the matter and as per kind order I interrogated the detained driver noted above and on demand he could not able to produce any valid documents in respect of loaded coal. I have directed them to produce the valid document through the owner or his representative at P.S by 10:00 hrs on 15.12.2022. Till 13:35 hrs on 15.12.2022 none produce any valid documents in respect of the aforesaid coal vide Purulia (T) PS GDE No- 967 dtd 15.12.2022. So, on preliminary enquiry it could be learnt that he with conspiracy of owner of said truck & others procured the said coal illegally from different places and were transporting the same in a clandestine manner to another district/state for wrongful gain. So, it is reasonable to believe that they were transporting the coal illegally after procuring by means of theft. Accordingly, I seized the above noted 05 (five) vehicles loaded with coal under proper seizure list duly signed by the accompanied Police persons in between 13:45 hrs to 14:25 hrs as there was no availability of any local person, as such I could not collect the signature of the local people in seizure list and during seizure I had taken 05 Kg coal from each seized truck as sample. After that I arrested them in between 14:30 hrs to 15:05 hrs after observing all formalities regarding their arrest. On suspicion ground said coal loaded 05 trucks by the said drivers are brought to PS after proper arrangement and kept at PS Campus.

Therefore, I pray that a specific case may kindly be registered against above noted Five (05) arrested accused persons (driver) and owner of the seized 05 (five) vehicles and other associates under proper section of law.
