



## Most respectfully begs to state:-

- 1. That on 28.09.2022 at about 11:30 P.M, when the elder brother of the complainant namely Hira Bauri, was returning home after completion of his work as a Toto (E-rickshaw) driver, and when he reached near our house, at that time the accused No. 1 and 2 started to abuse him in filthy languages, and when the elder brother of the complainant protested of their activities, the accused No. 2 and 3 started to assault my elder brother at random with fist, blows, kicks etc., by lying him on the road and when he raised his voice, hearing the hulla of Hira Bauri, the complainant and the witnesses No. 3 to 5 reached on the spot in order to save Hira Bauri and suddenly the accused No. 3 came to the spot with an iron rod and assaulted the complainant with the iron rod as a result the right hand of the complainant fractured.
- 2. That thereafter all the three accused persons assaulted the complainant and the witnesses and they also started to pelting stone and bricks and the accused person No. 3 pressed my neck in order to kill me by strangulation, and subsequently, some of the neighbors came to the spot and the accused persons fled away.
- 3. That the complainant was immediately taken to Deben Mahato Medical College and Hospital, Purulia and treated in the emergency and on the subsequent day he has to undergo through plaster on his right hand.
- 4. That after treatment, the complainant had been to the Purulia (T) P.S in order to lodge a complaint, but the duty officer refused to accept the same, accordingly the complainant posted the complaint through registered post on 31.10.2022, but after receiving the same no action has been taken by the police station.





 That subsequently, the Complainant on 03.11.2022 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.

It is therefore prayed that your Honour will be graciously pleased to send this petition to Inspector-in-charge of Purulia (T) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
