Sir,

In producing here with arrested 03 (three) accused persons namely (1) Sumanta Das @ Bura @ Suman (25) S/o Kalipada Das of Tantipara, Ward No 3, PS – Raghunathpur, Dist.- Purulia, (2) Sk Sukur (20) S/o Sk Pesur of Vill.- Hutmura, PS – Purulia (M), Dist.- Purulia and (3) Sunil Kr Jaiswal (38) S/o Suresh Jaiswal of Baburi, PS – Baburi, Dist.- Chandauli, Uttar Pradesh and seized articles (1) one iron made "BHOJALI" length approx 20 inch, (2) One Iron rod length approx 2.5 feet & Diameter 1.5 inch and (3) One knife having plastic butt length approx 15 inch lodged complain against them and 02 (two) others to the effect that on 01.12.2022 night at 21:35 Hrs received a credible source information that a gang of dacoits being armed with deadly weapons assembled at near Bhutama Jore (Sasankali Mandir) beside Ahallyabai road and preparing themselves for committing dacoity at Raghunathpur Town area. This diarized by duty officer ASI Gurucharan Sahis and as per order of I/C Raghunathpur PS myself along with C/-1517 Tinkori Chakraborty, C/-207 Dilip Kr Paul, C/-2461 Manas Gorai all of Raghunathpur PS vide CC No. 2371/22 dated 01.12.22 at Raghunathpur PS to work out the information. We reached near Bhutama Jore (Sasankali Mandir) beside Ahallyabai road at 22:15 Hrs leaving the Police vehicle some distance and proceeded for the anticipated place on foot. At 22:25 Hrs reached at anticipated place led on ambush being led by the source and in the moon light we noticed that 05 persons were assembled near Bhutama Jore (Sasankali Mandir) behind the bush and those persons are whispering from which it is clear that they are preparing themselves to commit dacoity at Raghunathpur PS area as it could be audible from the talks of the assembled criminals. We watched them and cordoned them. Then after disclosing our identity, I commended them to surrender but they did not pay any heed and tried to flee away. We succeeded in rounding up only 03 (Three) of them while the rest 02 persons were able to escaped despite hot chase after them. They disclosed their identity as mentioned above. We told them we want to searched them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the above noted articles from the exclusive possession of the above noted apprehended persons, after observing all formalities I seized the same under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat property in c/w above case. On interrogation they confessed their guilt and they stated that they have assembled there for committing house dacoity but they could not say about the names of other co-accused persons. I am to note here that I have to conducted search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity which may be endanger of life of Public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing dacoity at Raghunathpur PS area. So, after observing all formalities I arrested them preparing arrest memo and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Sumanta Das @ Bura @ Suman (25) S/o Kalipada Das of Tantipara, Ward No 3, PS – Raghunathpur, Dist.- Purulia, (2) Sk Sukur (20) S/o Sk Pesur of Vill.- Hutmura, PS – Purulia (M), Dist.- Purulia and (3) Sunil Kr Jaiswal (38) S/o Suresh Jaiswal of Baburi, PS – Baburi, Dist.- Chandauli, Uttar Pradesh along with 02 (two) unknown others under proper section of law and arrange its investigation.
