Rampada Kumbhakar of Vill- Ichhar, PS-Santaldih Dist- Purulia, along with 09 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle and 12 bottles seized country spirit styled as "Bamper" 300 ml in each bottle. I beg to state that today i.e on 01.12.2022 at 18.45 hrs acting on a tip off I along with force had been to the house of Gopal Kumbhakar (38 yrs) S/O - Lt. Rampada Kumbhakar of Vill- Ichhar, PS-Santaldih Dist-Purulia. This refers to Santaldih I/C BCW GDE No- 14 and C.C No- 1493/22 of dated 01.12.2022. I along with force held raid in the house of Gopal Kumbhakar. Seeing police van some unknown persons coming out from the house of Gopal Kumbhakar fled away. However I could be able to intercept Gopal Kumbnhakar. Out of seized bottles country spirit 01(One) bottle "DIL KHUSH" and 01 (one) bottle "Bamper" are kept as sample. I also arrested the accd. Gopal Kumbhakar (38 yrs) S/O - Lt. Rampada Kumbhakar of Vill- Ichhar, PS-Santaldih Dist- Purulia.

However the accd. Gopal Kumbhakar committed offence U/S 46A(c) B.E Act, 1909 for possessing and selling of country spirit in his house without any valid documents.
