Usually we provide group loan to the different villages and get collection by monthly mode to reach those particular villages. Each and every month we have some collection at Madhubanpur and Murulia on 2nd of month. Today when I was returning from Murulia in between 5:30 - 6:00 P.M., 2 unknown person blocked my road with wooden climb. They snatched my bike (Honda SP Shine, Black & Red colour, Reg NO. - JH 01 DH 3954, Engine NO. - JC73ET2131245, Chassis NO. - HE4JC737C JT 072625), Aadhaar Card (9569106734466), Voter Card (IA P1903699), ATM of Axis Bank and collected money Rs. 4550/- (Four thousand five hundred fifty).

Therefore, I request you to lodge an FIR against those snatchers and help me to find out my bike, money and rest all documents.
