Respected Sir,

I, Sudhir Tudu S/O- Lt. Jagannath Tudu of Vill- Tarpania, P.O- Ranga, PS-Bagmundi, Dist- Purulia, at present posted under Tamna PS, Dist- Purulia as ASI of Police producing herewith one arrested accused person namely Chakradhar Sahis (48 yrs) S/O- Lt. Rutu Sahis of Vill- Chipida, P.S- Tamna, Dist- Purulia with seized articles i.e. 1) one white colour plastic jerican containing approx. 08 Ltrs. of ID Liquor, 2) 05 pcs plastic glasses, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list.

I beg to submit that today (06.12.2022) during PS mobile duty acting of a secret source information myself along with i) JC/1397 Shyamal Hembram & ii) NVF/0151 Rajib Mahato both of Tamna PS conducted raid in the house of accused person namely Chakradhar Sahis S/O- Lt. Rutu Sahis of Vill- Chipida, P.S- Tamna, Dist- Purulia at about 19:25 hrs and found that he was keeping and selling of ID liquor at his house to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) One white colour plastic jerican containing approx. 08 Ltrs. ID Liquor, 2) 05 pcs plastic glasses, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample collected from seized articles from Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Chakradhar Sahis (48 yrs) S/O- Lt. Rutu Sahis of Vill- Chipida, P.S- Tamna, Dist- Purulia as per proper section of law.
