Entered the premises of Md.Yasin, S/o-Lt.Abdul Hasin, of vill-Panchudanga (Ekta para), P.O. + P.S. - Adra, Dist – Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he was consuming Electricity dishonestly and unauthorized through bypassing arrangement in the incoming service cable before energy meter from his Domestic connection having Consumer ID – 242216827 present inside his premises.

From the above inspection it was found that he was using the following Electrical equipments i.e.

- 1. 2 Nos Fan (60 watt each): 2X60 = 120 watt.
- 2. 2 Nos CFL (15 watt each): 4X15 = 30 watt.
- 3. 1 No. TOTO (1000 watt): 1x1000 = 1000 watt.

Total = 1150 watts.

Section of Service cable (black color), 2 core 6 Sq. mm, of length approx 3ft.
